**FINAL ORDER ON PETITION FOR PERMISSION TO RELOCATE HISTORICAL
MARKER HONORING ROBERT H. "BOB" WHITE PURSUANT TO TENN. CODE
ANN. § 4-1-412(h)**

This matter came before the Tennessee Historical Commission (hereinafter "the Commission") upon the Petition of the Crockett County Veterans Memorial Association pursuant to Tenn. Code Ann. § 4-1-412(h). Upon review, the Commission finds that:

1. The Tennessee Historical Commission has jurisdiction of this case pursuant to the Tennessee Heritage Protection Act of 2016 codified at Tenn. Code Ann. § 4-1-412.
2. This Petition requests permission from the Commission to allow Petitioner to relocate historical marker 4D 38 honoring Robert H. "Bob" White located on the Southwestern corner of the Crockett County courthouse lawn in Alamo to the Northwestern corner of the Crockett County courthouse lawn in order to permit Petitioner to erect "Gold Star" and "Blue Star" markers, which honor American soldiers and their families who are from Crockett County, Tennessee.
3. Robert H. "Bob" White was born in Crockett County, Tennessee and served as Tennessee's first official state Historian for fifteen years. After his death in 1970, historical marker 4D 38 was erected on the Southwestern corner of the

Crockett County courthouse lawn in his honor. Such marker has remained as originally located since it was first erected.

4. Petitioner is an Association that was organized on August 30, 2007 to erect and maintain the Crockett County Veterans Memorial Monument to honor and preserve the legacy of Crockett County Veterans.
5. The Crockett County Veterans Memorial Monument groundbreaking was held on July 11, 2008, and the Monument was thereafter erected on the Southwestern corner of the Crockett County courthouse lawn. It was dedicated at a ceremony held on November 11, 2008.
6. The historical marker honoring Dr. White is situated between the Veterans Memorial Monument and the nearest roadway, which is State Highway 88 that runs through the city of Alamo directly in front of the courthouse lawn.
7. The Association desires to erect a "Gold Star" memorial honoring Crockett County's "Gold Star" families who have lost loved ones in the service of our country and a "Blue Star" memorial honoring all of those from Crockett County who have served in the United States armed forces in the place where Dr. White's historical marker currently stands.
8. The Crockett County Commission has adopted a resolution authorizing the Association to relocate Dr. White's historical marker to the Northwest corner of the courthouse lawn, at the Association's cost, in order to allow the Association to erect "Gold Star" and "Blue Star" markers in its place. A copy of such resolution is referenced as Exhibit 5 to Petitioner's petition.


9. Petitioner's petition was filed pursuant to Tenn. Code Ann. § 4-1-412(h), such that no publication notice was given as no such notice is required under that statute.
10. Petitioner is not aware of any relatives of Robert H. "Bob" White or any other person or entity who has a specific interest in this matter greater than that of the general public. In addition, Petitioner is only requesting that it be allowed to move Dr. White's historical marker approximately 100 feet North of its current location, at which location such marker will have the same visibility from State Highway 88 as it currently does, and it will likewise have the same access from the courthouse lawn as it currently has.
11. A drawing showing the current locations of Dr. White's historical marker and the Veterans Memorial Monument as well as the proposed new location for Dr. White's historical marker is attached as Exhibit 6 to the petition and verifies the assertions made by Petitioner regarding relocation of the marker at issue.
12. The cost to relocate the marker will be de minimis, and Petitioner has agreed to pay any and all such costs with the approval of the Crockett County Commission.

WHEREFORE, UPON CONSIDERATION OF THE FOREGOING, the Tennessee Historical Commission, pursuant to Tenn. Code Ann. § 4-1-412(h), finds that allowing the relocation of Historical Marker 4D 38 honoring Robert H. "Bob" White located on the Southwestern corner of the Crockett County Courthouse lawn in Alamo to the Northwestern corner of the Crockett County Courthouse lawn in Alamo in order to allow the Crockett County Veterans Memorial Association to erect "Gold Star" and "Blue Star"

markers honoring American soldiers and their families who are from Crockett County, Tennessee, in its place serves the purposes of the Tennessee Historical Protection Act and is in the best interests of the public. **THEREFORE, IT IS SO ORDERED.**

Comes now Petitioner Crockett County Veterans Memorial Association (hereinafter "Association") and hereby petitions the Tennessee Historical Commission to allow it to relocate historical marker 4D 38, erected in Alamo, Crockett County, Tennessee to honor Robert H. "Bob" White, as follows:

1. Robert H. "Bob" White was born in Crockett County, Tennessee and served as Tennessee's first official state Historian for fifteen years. After his death in 1970, historical marker 4D 38 was erected on the Southwestern corner of the Crockett County courthouse lawn in his honor. Such marker has remained as originally located since it was first erected. (Marker description attached hereto as **Exhibit 1** and hereby referred to and incorporated herein by reference).

2. The Association was organized on August 30, 2007 to erect and maintain the Crockett County Veterans Memorial Monument to honor and preserve the legacy of Crockett County Veterans. (Copy of Association bylaws attached hereto as **Exhibit 2** and hereby referred to and incorporated herein by reference).

2. The Crockett County Veterans Memorial Monument groundbreaking was held on July 11, 2008 and the Monument was thereafter erected on the Southwestern corner of the Crockett County courthouse lawn. It was dedicated at a ceremony held on November 11, 2008. (Copy of dedication article attached hereto as **Exhibit 3** and hereby referred to and incorporated herein by reference).

3. The historical marker honoring Dr. White is situated between the Veterans Memorial Monument and the nearest roadway, which is State Highway 88.

4. The Association desires to erect a "Gold Star" memorial honoring Crockett County's "Gold Star" families who have lost loved ones in the service of our country and a "Blue Star" memorial honoring all of those from Crockett County who have served in the United States armed forces in the place where Dr. White's historical marker currently stands. (Documents describing "Gold Star" and "Blue Star" memorial markers attached hereto as collective **Exhibit 4** and hereby referred to and incorporated herein by reference).

5. The Crockett County Commission has adopted a resolution authorizing the Association to relocate Dr. White's historical marker to the Northwest corner of the courthouse lawn, at the Association's cost, in order to allow the Association to erect "Gold Star" and "Blue Star" markers in its place. (Copy of resolution attached hereto as **Exhibit 5** and hereby referred to and incorporated herein by reference).

6. This petition is filed pursuant to Tenn. Code Ann. § 4-1-412 (h), such that no publication notice has been given as no such notice is required under that statute.

7. The Association is not aware of any relatives of Robert H. "Bob" White or any other person or entity who has a specific interest in this matter greater than that of the general public. In addition, the Association is only requesting that it be allowed to move Dr. White's historical marker approximately 100 feet North of its current location, at which location such marker will have the same visibility from State Highway 88 as it currently does, and it will likewise have the same access from the courthouse lawn as it currently has. Given this, no one who has a specific interest in Dr. White's historical marker nor anyone in the general public will suffer any prejudice as a result of such marker being moved from its current location.

8. The Association is not aware of a material or substantial need for relocating the historical marker, but the Association requests this waiver in order that its efforts to honor Crockett County's veterans may be located in one area on the courthouse lawn, and the Association believes that moving Dr. White's historical marker will not adversely affect any other person or entity.

9. A drawing showing the current locations of Dr. White's historical marker and the Veterans Memorial Monument as well as the proposed new location for Dr. White's historical marker is attached hereto as **Exhibit 6** and is hereby referred to and incorporated herein by reference.

WHEREFORE, Petitioner prays that the Tennessee Historical Commission allow the Association to relocate historical marker 4D 38 at its cost as set forth herein.

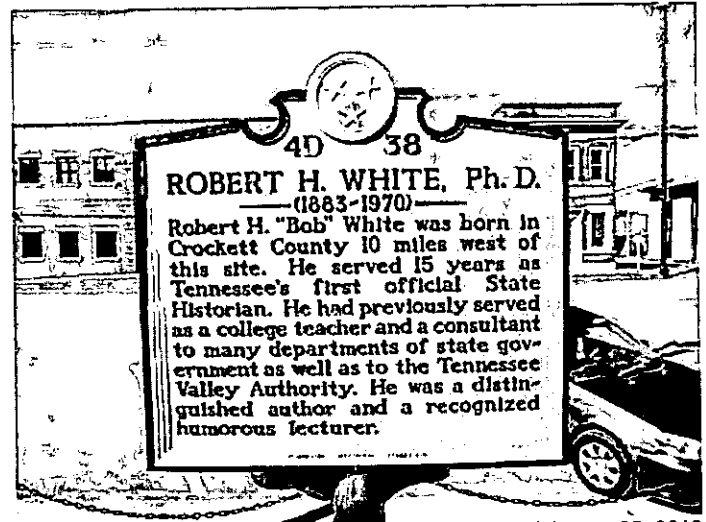

BYLAWS OF THE CROCKETT COUNTY VETERANS MEMORIAL ASSOCIATION

As Adopted March 27, 2023

ARTICLE I

Name

The name of this organization shall be the CROCKETT COUNTY VETERANS MEMORIAL ASSOCIATION (hereinafter "the Association").

We were initially organized on August 30, 2007.

ARTICLE II

Objects

The objects of this Association shall be:

1. To erect and maintain the Crockett County Veterans Memorial Monument to honor and preserve the legacy of Crockett County Veterans.
2. To verify eligibility requirements are met before the Association arranges for the name of the veteran to be inscribed on the Monument.
 - a. Eligibility Requirements will be verified utilizing DD form 214 as follows:
 - i. The DD Form 214 "Home address at time of entry" or "home of record" must state Crockett County, Tennessee or the city, town, or unincorporated community therein.
 1. If the DD Form 214 "Home address at time of entry" or "Home of record" does not state Crockett County, Tennessee, but the address at time of entry can be verified by property tax records as within the Crockett County zoning designation, then eligibility requirement i. has been met.
 - ii. A "veteran" is defined as (38 U.S.C. § 101 Definitions (2)) a person who served in the active military, naval, air or space service, and who was discharged or released therefrom under the conditions other than dishonorable.
 - iii. "Active military" is defined as (38 U.S.C. § 101 Definitions (2)):
 1. Full-time duty in the Armed Forces, other than active duty for training;
 2. Full-time duty (other than for training purposes) as a commissioned officer of the Regular or Reserve Corps of the Public Health Service (i) on or after July 29, 1945, or (ii) before that date under

circumstances affording entitlement to "full military benefits" or (iii) at any time, for the purposes of chapter 13 of this title;

3. Full-time duty as a commissioned officer of the National Oceanic and Atmospheric Administration or its predecessor organization the Coast and Geodetic Survey (i) on or after July 29, 1945, or (ii) before that date (i) while on transfer to one of the Armed Forces, or (ii) while, in time of war or national emergency declared by the President, assigned to duty on a project for one of the Armed Forces in an area determined by the Secretary of Defense to be of immediate military hazard, or (iii) in the Philippine Islands on December 7, 1941, and continuously in such islands thereafter, or (iii) at any time, for the purpose of chapter 13 of this title;
4. Service as a cadet at the United States Military, Air Force, or Coast Guard Academy, or as a midshipman at the United States Naval Academy; and
5. Authorized travel to or from such duty or service.

iv. In the event a veteran's eligibility is uncertain, 38 U.S.C. § 101 should be referenced for a more detailed description of all eligibility requirements and definitions.

3. To vote on whether the veteran's name should be added to the Monument once the Association has determined that the veteran meets the eligibility requirements set out in Paragraph two (2) above. A majority vote of the approved members of the Association who are present at a duly called meeting of the Association shall be required to approve adding the veteran's name to the Monument.
4. To have the veteran's name inscribed upon the Monument upon final approval by the Association as set forth above.
5. To raise and manage funds to provide for the erection, maintenance, and publicizing of the Crockett County Veteran's Memorial Monument.
6. To cooperate with all public, private, and/or religious agencies and/or professional groups in the furtherance of our goal; to serve as a clearing house for gatherings and giving out information regarding our projects and activities; and to solicit and receive funds and materials for the accomplishment of the above purposes.

ARTICLE III

Members

Membership on this Association will be open to persons of good character and community standing who express an interest in the furtherance of the objects of the Association stated herein.

The only voting members of the Association shall be the Elected Officers of the Association and any other persons who have been accepted for membership by an affirmative vote of a majority of the Association members present at a regular or specially called meeting of the Association. The Association Secretary shall compile and maintain a list of all members qualified to vote on Association business.

There will be no membership fees or annual dues.

ARTICLE IV

Officers

The officers of this association shall consist of Chairman, Vice-Chairman, Treasurer, and Secretary. These officers shall perform the duties prescribed by these Bylaws without compensation.

The duties of the officers shall be:

- a. The Chairman shall be the executive officer of the Association and will preside at meetings of the Association. The Chairman shall present the views and aspirations of the Association and promote the growth of the Association in every way possible.

The Chairman shall perform such other duties as usually pertains to such an office. The Chairman shall be authorized to sign checks.

- b. The Vice-Chairman shall assist the Chairman in the work of the Association. In the absence of the Chairman, the Vice-Chairman shall perform all duties of that office and shall serve as Chairman until such time that a new Chairman can be elected should a vacancy occur.
- c. The Treasurer shall receive all funds paid to this Association and shall deposit same in the official depositories, and shall disburse same in accordance with the vote of the membership. The Treasurer's accounts and books shall be open for inspection at all times to the members and authorized auditors, and the Treasurer shall report to the membership at each meeting.
- d. The Secretary shall keep a record of all meetings and retain a file for future reference.

Officers shall be elected each year at the October meeting or as soon thereafter as practicable, and each officer shall be elected by a majority vote of the members present

at such meeting after a call for nominations. Elections shall be by voice vote unless an Officer or member requests that the vote be taken by secret, written ballot. The Secretary shall count any written ballots, except for the office of Secretary, which shall be counted by the outgoing or incoming Chairman.

Officers shall serve for a term of one year or until their successors are elected. There shall be no limitation on the number of consecutive terms that a person may serve in a particular office, but no member may hold more than one office at a time. The membership shall fill any vacancies at the next regular or specially called meeting following such vacancy occurring.

ARTICLE V

Meetings

Regular meetings of this Association shall be held at such times and places decided by the Officers and/or membership. Special Meetings may be called by the Chairman or at the request of four members of the Association. The purpose of any specially called meeting must be stated in the call. Except in cases of emergency, at least five days' notice of any meeting shall be given to the Officers and the membership.

Five members of this Association, including one Officer, shall constitute a quorum for any meeting.

ARTICLE VI

Parliamentary Authority

The rules contained in the most recent edition of ROBERT'S RULES OF ORDER shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with these Bylaws.

ARTICLE VII

Amendments

Any amendment to these Bylaws must be adopted by a two-thirds (2/3) majority vote of the membership present at any meeting of this Association, provided that written notice of the proposed amendment shall have been given to the members at least two (2) weeks prior to the meeting. There shall be no voting by proxy.

Crockett County Veterans Memorial



Mrs. Jeanne Tritt Mathis had a vision – she wanted Crockett County to recognize the military service of its men and women, past and present. She believed that the veterans from Crockett County deserved recognition for their patriotic service to this great country.

After successfully recruiting Bobby Cates to spearhead the Memorial effort, sadly Jeanne died in August 2007 before the newly formed committee could meet. However, the committee felt it should continue with the project and dedicate it in memory of Jeanne. Private donations and servicemen & women for the Memorial began to come in from county residents. Expectations were quickly surpassed as word spread about this visionary memorial. What was initially thought to be a multi-year project was planned, designed, funds raised, and erected in just over a year. In itself, it is a great tribute to all the citizens of Crockett County.

The committee reviewed four proposals and unanimously selected Greenfield Monuments to design, engrave, and install the granite tablets. The Memorial consists of one black center stone tablet, one bench dedicated to the memory of Jeanne Mathis, and 15 additional tablets that display the names of all county service men and women who have served from World War I to present day. The black tablet displays the 82 local names who sacrificed all for their country during service in World War I, World War II, Korea, and Vietnam. The fifteen tablets reflect 4,962 names of servicemen and women who have served our country on active duty. Each monument sits on a double granite base. The entire monument is wheelchair accessible.

The Memorial was dedicated on Veterans Day, November 11th, 2008, a mere 15 months after the initial committee meeting. Out of our county, donations were received from states such as NC, VA, AL, CA, AZ, MS, GA, & FL. By the end of 2008, almost \$70,000 had been collected. The Memorial cost \$46,000. Another \$9,000 was spent on such things as site preparation, concrete, sod/landscaping, advertising, & more. The cost to add 381 additional names in 2009 and 2010 was \$19,000. Names are added each October. The Memorial committee continues to discuss such items as security, maintenance & upkeep of the memorial, fundraising for its perpetual care, adding of names, and photo internet site. To further emphasize its maintenance and upkeep funding, Crockett County Veterans Association established a "Friends of the Memorial" program in 2011. Qualified members receive a Veterans Memorial commemorative coin which reflects its dedication date of November 11, 2008; and new members who join before November 2014 will be recognized on a plaque which will be dedicated on Veterans Day 2014.

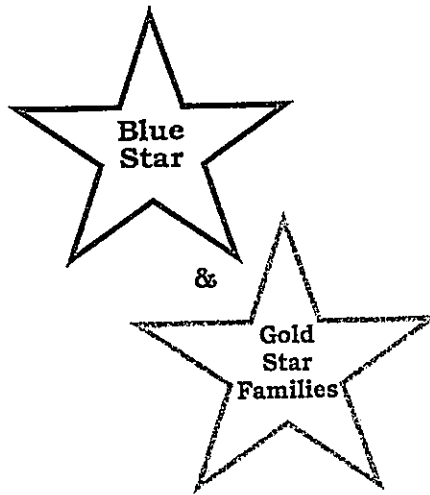
The Blue Star Memorial Marker Program of the National Garden Clubs, Inc. began in 1945 to honor the men and women serving in the Armed Forces during World War II.

The name was chosen for the star on flags displayed in homes and businesses denoting a family member serving. Garden clubs pictured a ribbon of living memorial plantings traversing every state. The designation of Blue Star Highways was achieved through petitions to the state legislatures and cooperation with the Departments of Transportation. A uniform Marker was designed to identify the Highways.

Blue Star Memorial Markers extend thousands of miles across the United States, and honor all our Armed Forces of the United States. Blue Star Memorial Markers continue to be dedicated each year on highways, at Veterans' facilities, National Cemeteries, parks, and civic and historic sites, showing our appreciation for those who defended our country

Gold Star Families mission is to offer honor, hope and healing through remembering fallen heroes by coming together.

While their hero paid the ultimate sacrifice for our freedom, survivors live daily with the pain of the sacrifice. 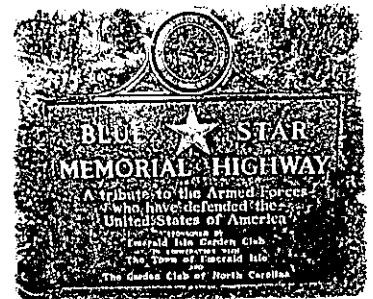

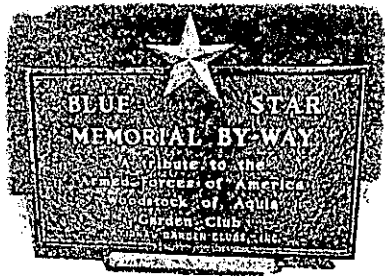

No Blue Star or Gold Star Families Marker may bear an individual's or Family's name. The Blue Star Markers are designed to pay tribute to the Armed Forces as a whole. The Gold Star Families Marker honors the families whose loved one paid the ultimate price defending the United States of America.

Procedure for obtaining Blue and/or Gold Star Families Markers

- Garden clubs decide to purchase and/or sponsor a Marker (Gold Star Families). An appropriate location is selected for the type of Marker chosen.
- Contact the State Blue Star Memorial Chairman for forms and instructions.
- Contact local or state authority responsible for location.
- Mail order form and check to NGC Chairman for processing.
- Clubs may solicit other civic organizations to help with funding, construction, planting, and maintenance.
- Allow at least twelve to sixteen weeks for delivery of Marker after an order is received by Sewah Studios.

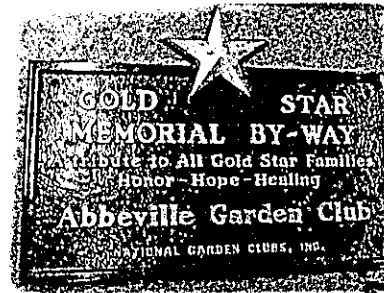

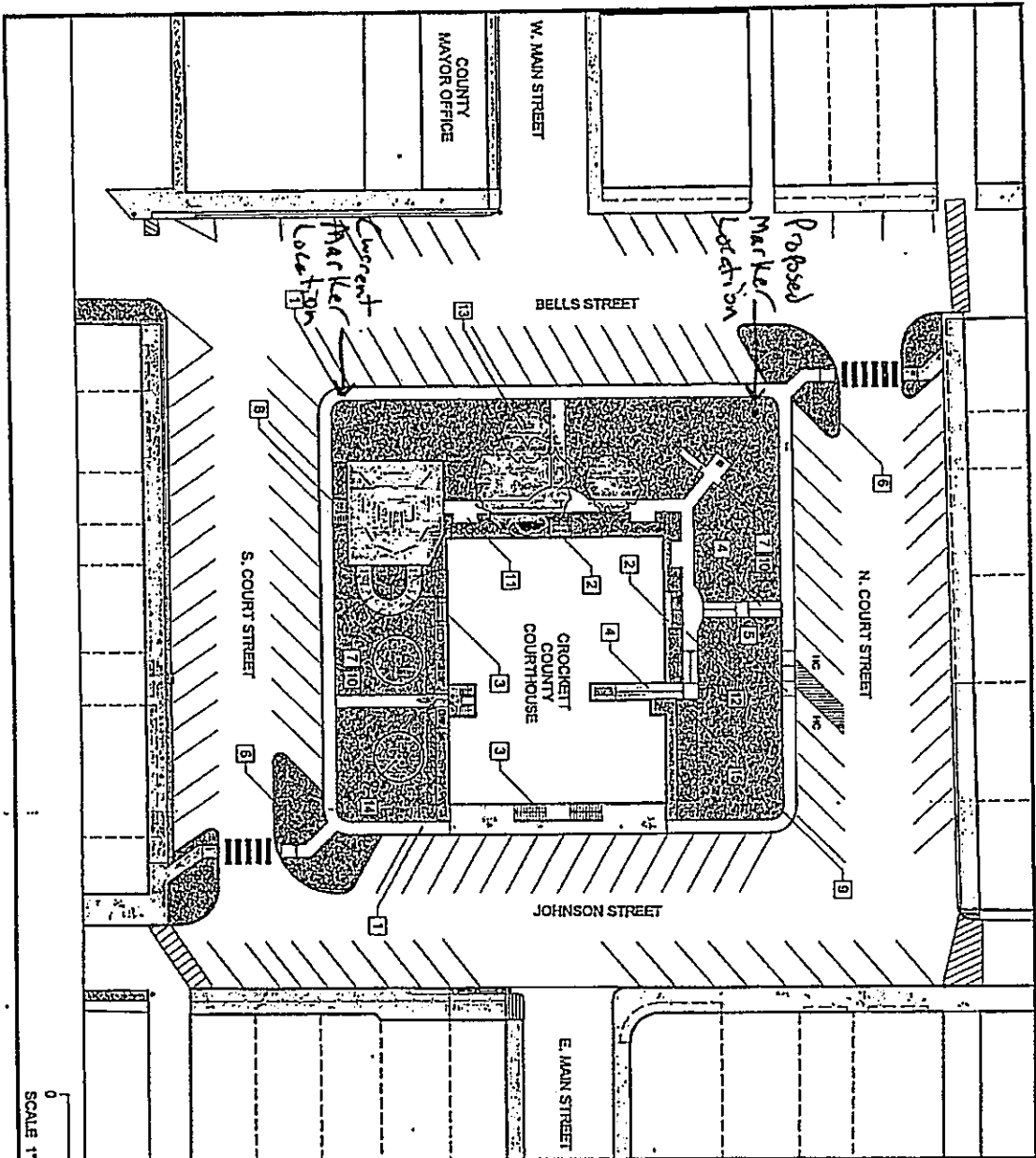
