Spotlight Article: Joe Swinford

Imagine working in a position where your day begins with a call from one someone who is unable to access the service they desperately need and later that afternoon you are part of a departmental working group meeting to address systemic problems. Many times the systemic issues are the very ones faced by the caller

from earlier in the morning. Joe Swinford has this unique opportunity in his role as Director of the Office of Consumer Affairs for the Tennessee Department of Mental Health and Developmental Disabilities. In this position Joe has the chance to not only help resolve problems faced by people served by his department on a individual basis, but also the chance to deal with the root causes of these problems. As the primary link to the service recipients and a member of the management team, Joe plays a key role in making TDMHDD a responsive, well managed agency.

In the summer of 2003, Joe was selected to participate in the 2003 Class of the Tennessee Government Executive Institute (TGEI). Through his TGEI experience, Joe gained new insights into leadership principles and practices, networked with other state government professionals, analyzed trends in business, and assessed his own work and leadership styles. Thanks to TGEI's leadership and team-building activities, Joe returned to TDMHDD with renewed enthusiasm for serving the citizens of Tennessee. TGEI also benefited for Joe's participation through his selection as President for the Class of 2003. In addition to leading his classmates in activities such as raising funds for the TGI Endowment, he serves as a member of the TGEI steering committee. He sees TGEI as an essential tool for ensuring that the citizens of Tennessee will always have the skilled capable leaders needed to serve them.

Public services have long been a part of Joe's professional career. After earring his bachelor's degree from The University of Tennessee at Chattanooga in music education, Joe taught school in southeast Tennessee and northwest Georgia. Dr. Robert M. Smith Selected as Next President of Slippery Rock University of Pennsylvania

Following an 11 month national search, the Executive Committee of the Pennsylvania State System of Higher Education's Board of Governors has selected Dr. Robert M. Smith to serve as the next president of Slippery Rock University of Pennsylvania. Dr. Smith has served as Slippery Rock's interim president since December 2002.

Dr. Smith earned a bachelor's degree in speech communication with minors in mathematics and education from Wichita State University, a master's degree in interpersonal communication from Ohio University and a doctoral degree in communication theory with a minor in research methodology from Temple University.

Upon graduating from Wichita State in 1967, Dr. Smith joined the University's faculty as an associate professor of communications, a position he held for 10 years. In 1987, Dr. Smith joined the faculty and administration at the University of Tennessee at Martin as a full professor in the Department of Communication and dean of the School of Arts and Sciences. He also served as executive director of WestStar Leadership Development Program from 1989-1999 and as director of the Tennessee Governor's School for the Humanities from 1996-1999. We all know his best because of his dedication and commitment to the Tennessee Government Executive Institute, where he has served as a facilitator for many years.
