The Tennessee Department of Human Services' Assistant Commissioner for Rehabilitation Services, Carl Brown, recently announced that he would be retiring from state government at the end of June after 41 years of service.

Assistant Commissioner Brown provided great leadership to Tennessee's Vocational

Rehabilitation Program and challenged his staff across the state to continuously improve their performance in providing services to individuals with disabilities. He worked tirelessly for the Division of Rehabilitation Services in numerous positions to ensure individuals with disabilities receive quality rehabilitation services to meet their needs.

Mr. Brown began his career in state service as the manager of the Tennessee Vocational Training Center in Franklin. He was soon promoted to Facility Supervisor, having responsibility for all Middle Tennessee Vocational Training Centers. In 1979 Mr. Brown became the district supervisor for Vocational Rehabilitation, working out of the Columbia regional office. In 1983, he assumed responsibilities as Regional Supervisor. Mr. Brown came to Vocational Rehabilitation Services Central Office in Nashville in 1989 as Director of Field Operations and served in that position until his appointment to Assistant Commissioner in 1998.

Mr. Brown served on numerous state agency councils and commissions. He served on the Executive Committee of the Council of State Administrators of Vocational Rehabilitation (CSAVR). He was also chairman of the Direct Client Services Committee with CSAVR. Mr. Brown served as Chairman of the 29<sup>th</sup> Institute on Rehabilitation Issues Primary Study Group. He is a recipient of the H. B. Cummings Award exemplifying the highest standards of leader-ship as rehabilitation professional.

Mr. Brown received his undergraduate education at Middle Tennessee State University. He earned a Master's Degree in Rehabilitation Counseling from the University of Memphis. He completed the Academy for Executive Leadership with the National Executive Leadership Institute in Rehabilitation from the University of Oklahoma, and is an alumnus of the prestigious Tennessee Government Executive Institute.

Assistant Commissioner Brown provided the seventeen community Tennessee Rehabilitation Centers across this state with a tremendous amount of support. He understands the importance of a rehabilitation center to those individuals who need specialized rehabilitation services. He also attended every graduation at the Tennessee Rehabilitation Center at Smyrna.

Assistant Commissioner Brown was a member of the TGEI Class of 1991.

# Spotlight Article: Office of Consulting Services

Established last summer, OCS offers general management consulting for state agencies at no cost to the client agency. OCS has strong ties to TGEI and its staff has a wide range of state government and private business experience. OCS is headed by Ron Maupin (TGEI Class of 2000), as part of the RDS Division, run by Buddy Lea (TGEI Class of 1999), and with Emily Passino (TGEI Class of 2002) as a senior management consultant.

In practical terms, this means that there is now an office you can call on for management help. If your department is like most state agencies, the processes of your daily work evolved over many years and is not as efficient or as effective as your team would like it to be. And, most likely, your focus is on getting the job done day in and day out – not on transforming and updating processes.

As discussed in more detail in their <u>website</u>, OCS can collaborate with you

- To collect and analyze data,
- To map business processes,
- To facilitate groups and meetings,
- To research and identify best practices
- · To evaluate programs and recommend improvements, and
- To assist with complex projects.

"The OCS team functions as a state government management consulting team," said Buddy Lea. ``It's easy to recognize when a process or system isn't working well, but it's much harder to know where to begin fixing it, or how to successfully challenge the status quo. This group can help."
