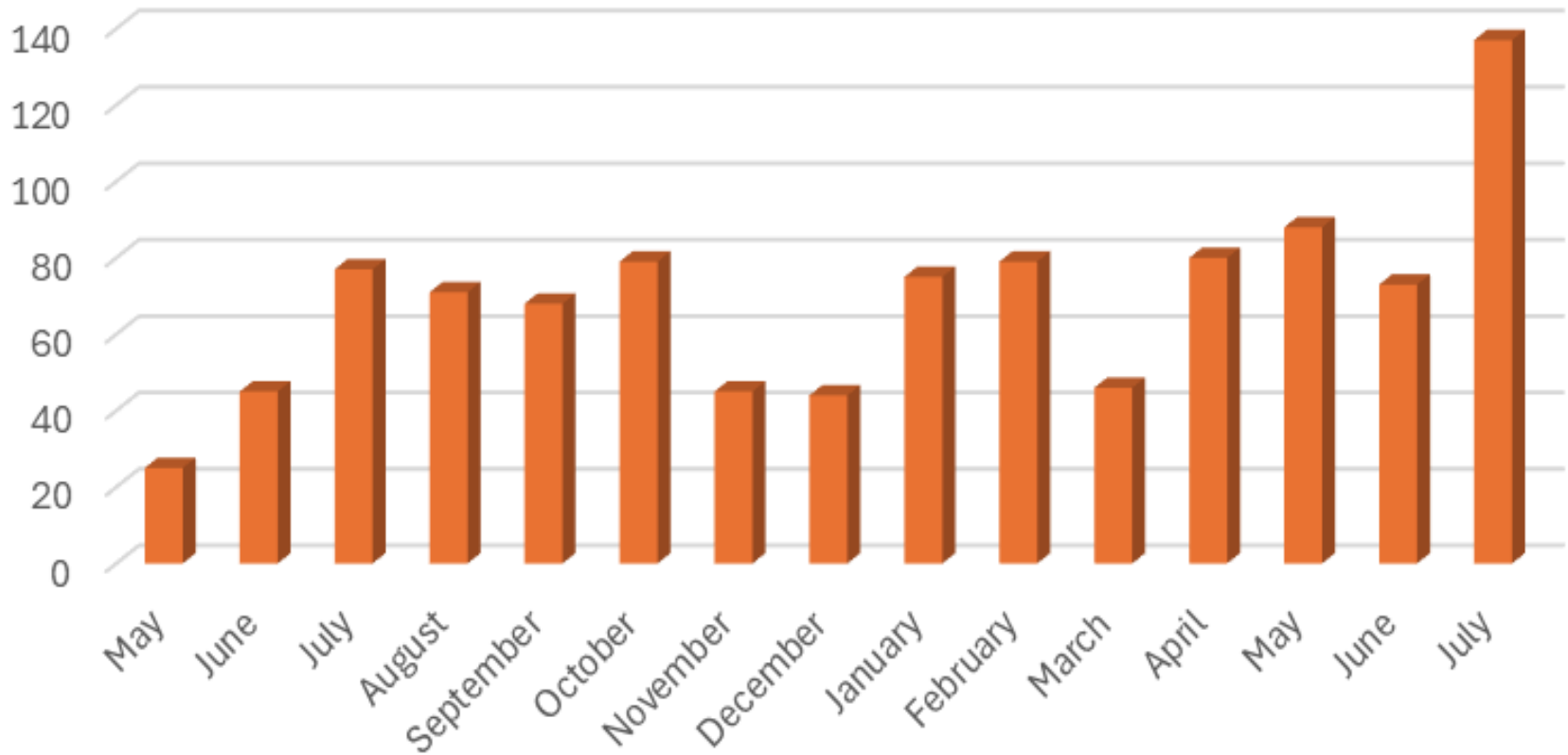

Referrals and Enrollments Through July 2024

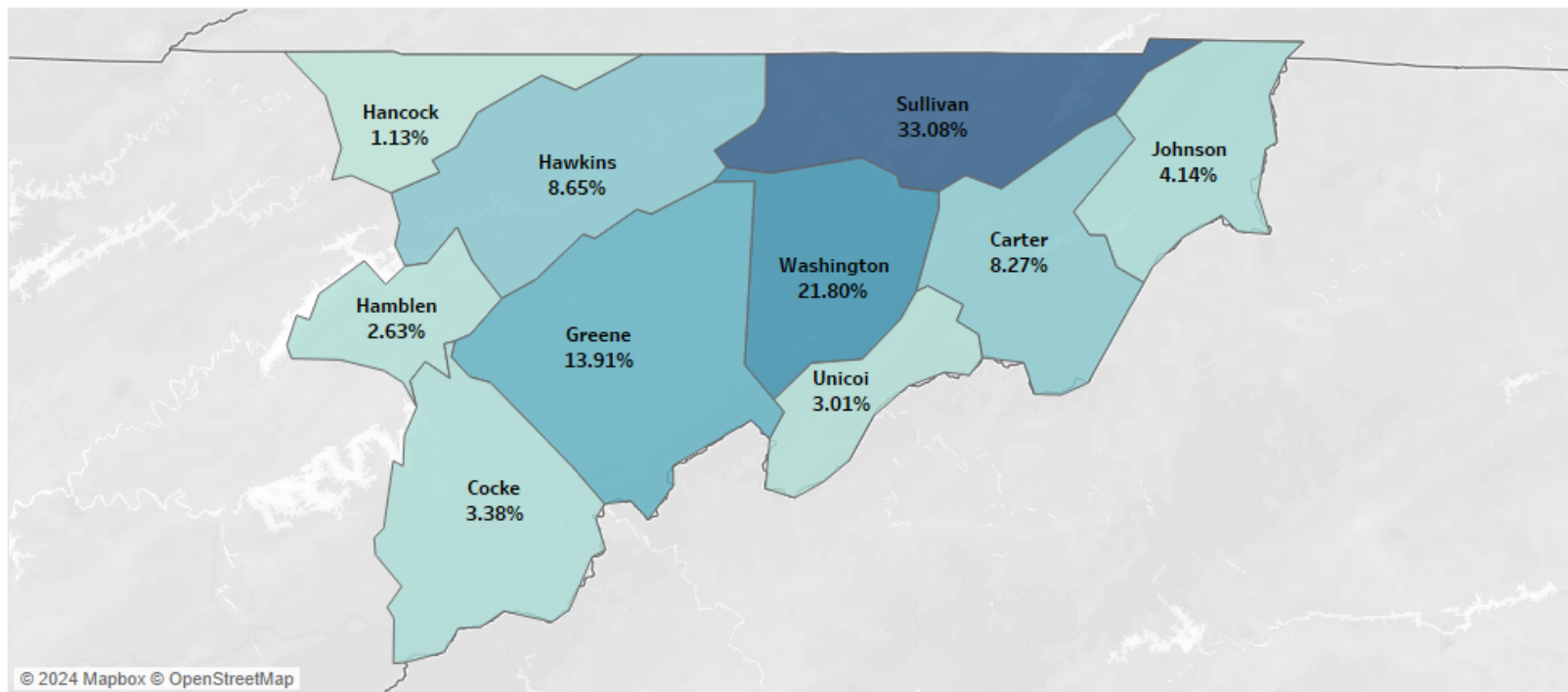


Referrals Into the Program

Enrollment Percentage by County



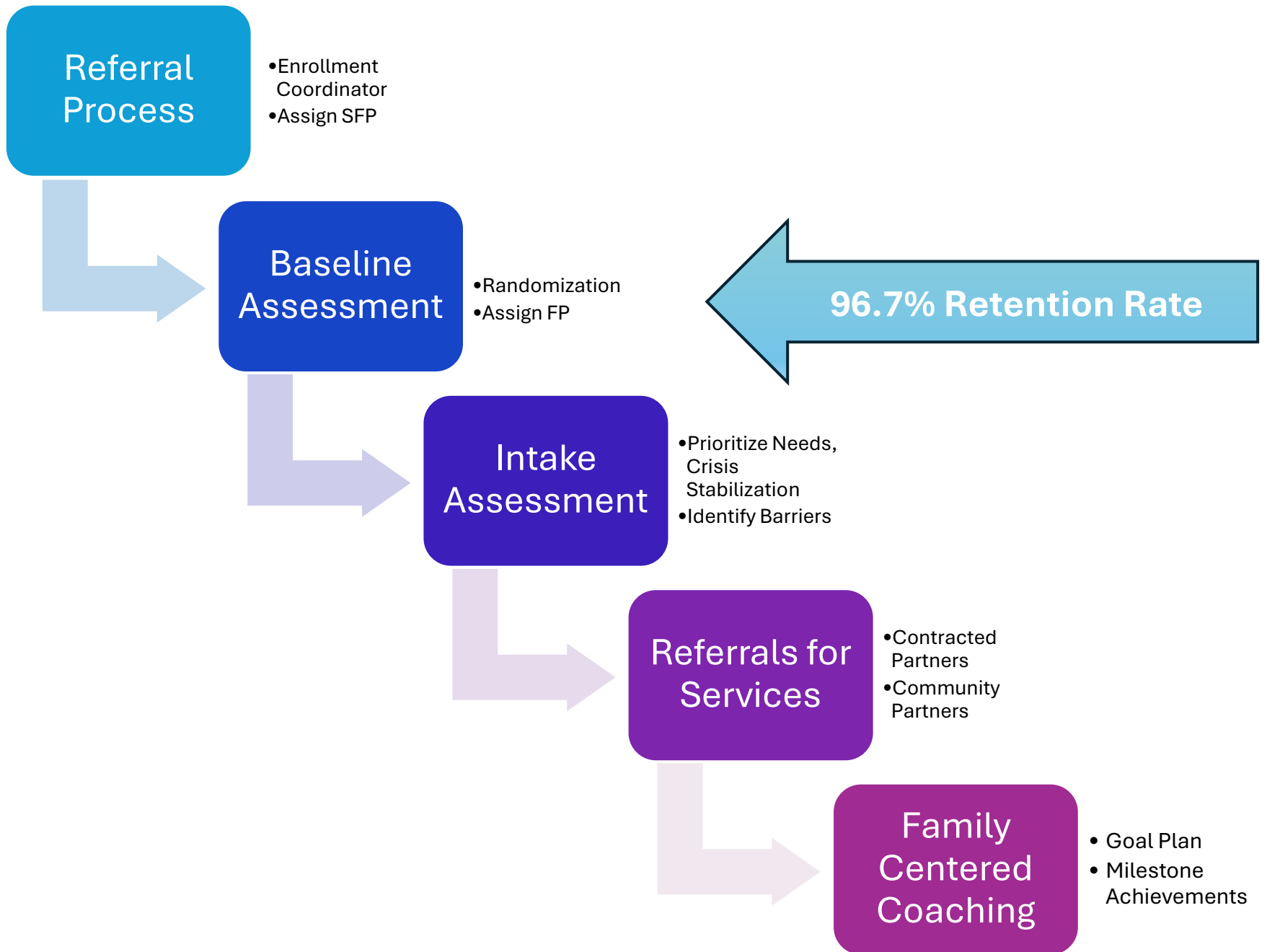

Enrollment Challenges and Solutions

- UAT available end of June/July 2023 – 1 year of enrollments
- Several prominent community partners received Families First Community Grants which are very similar to our design and thus are not referring for fear of duplication of services.
- Expanded recruitment strategies:
 - Social media campaign launched May 2024
 - Targeted education with community partners
 - Greater focus on outreach events and presentations
 - Additional marketing staff for targeted marketing and deep community level engagement with the target population
- We are confident we'll reach our target of 792 enrolled families by 12/31/24

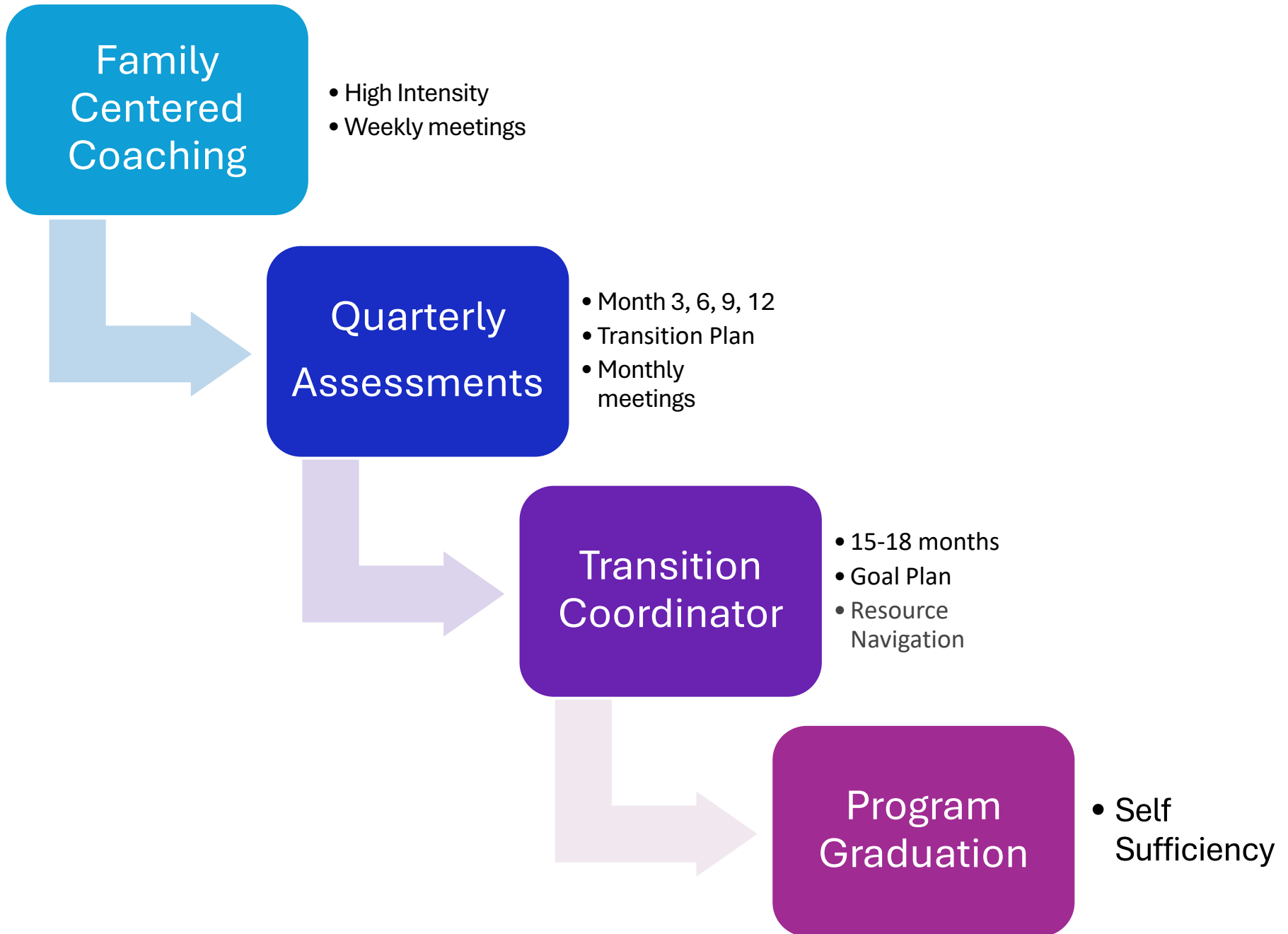

Family Partner Services

- High Intensity, Low Caseload
- Family Centered Coaching
- Goal Setting/Planning, Information Support/Assistance, Community Resource Navigation, Unite Us Referrals, Motivational Interviewing

Financial Support Services

- Milestone payments (to families)
- Barrier removal payments (to vendors/merchants/providers)
- Transitional benefits payments (to vendors/merchant/providers)

Behavioral Health Services

- Expedited access to mental health counseling
- Addiction treatment/recovery services

Specialized Training & Assistance

- Parent education
- Financial counseling
- Career assessment/planning and job training
- Family power building



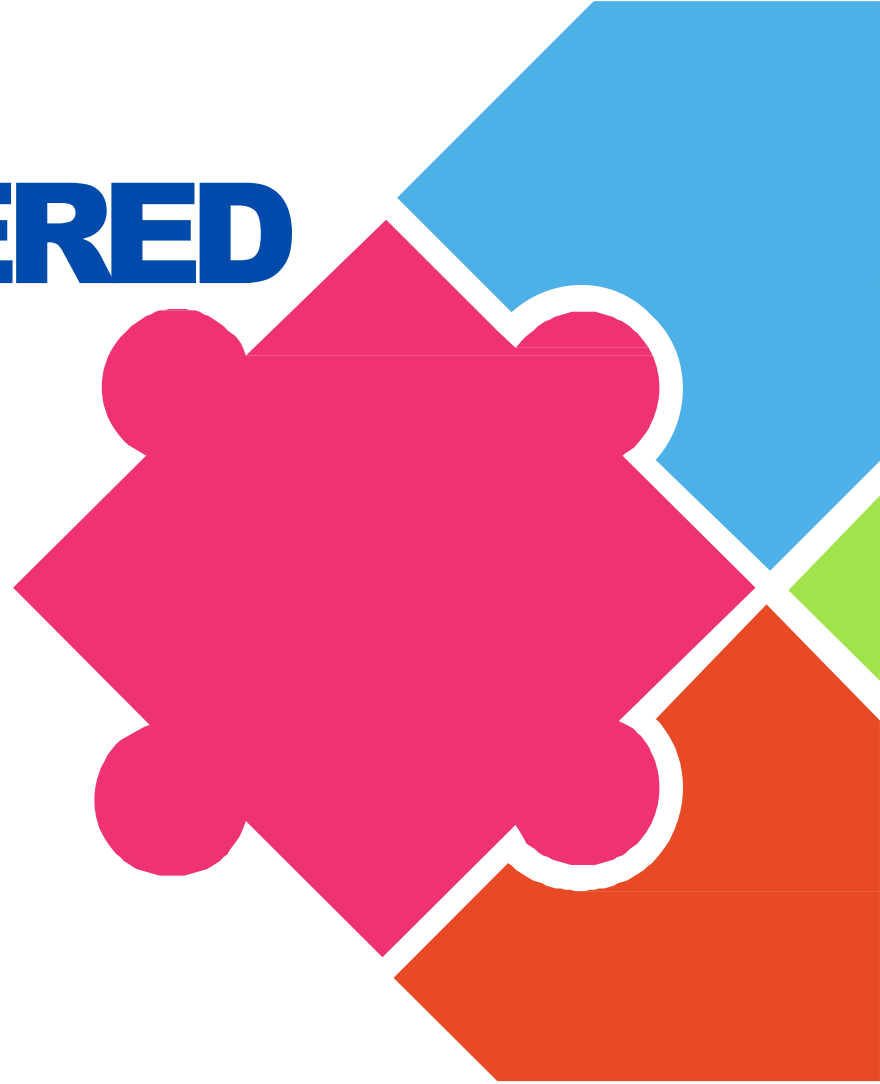
Family Partners



- Family Partners are professionals trained in family centered coaching, whole family services, motivational interviewing, community resource navigation, and more.
- Family Partners have life experience or have worked with low-income, are a cultural and linguistic match for the families they serve and reside in or near the communities where their enrolled families live.
- Each Family Partner has a caseload of 12-15 families at a time to ensure high intensity coaching remains equitable. The average enrollment of families will be 15 months.

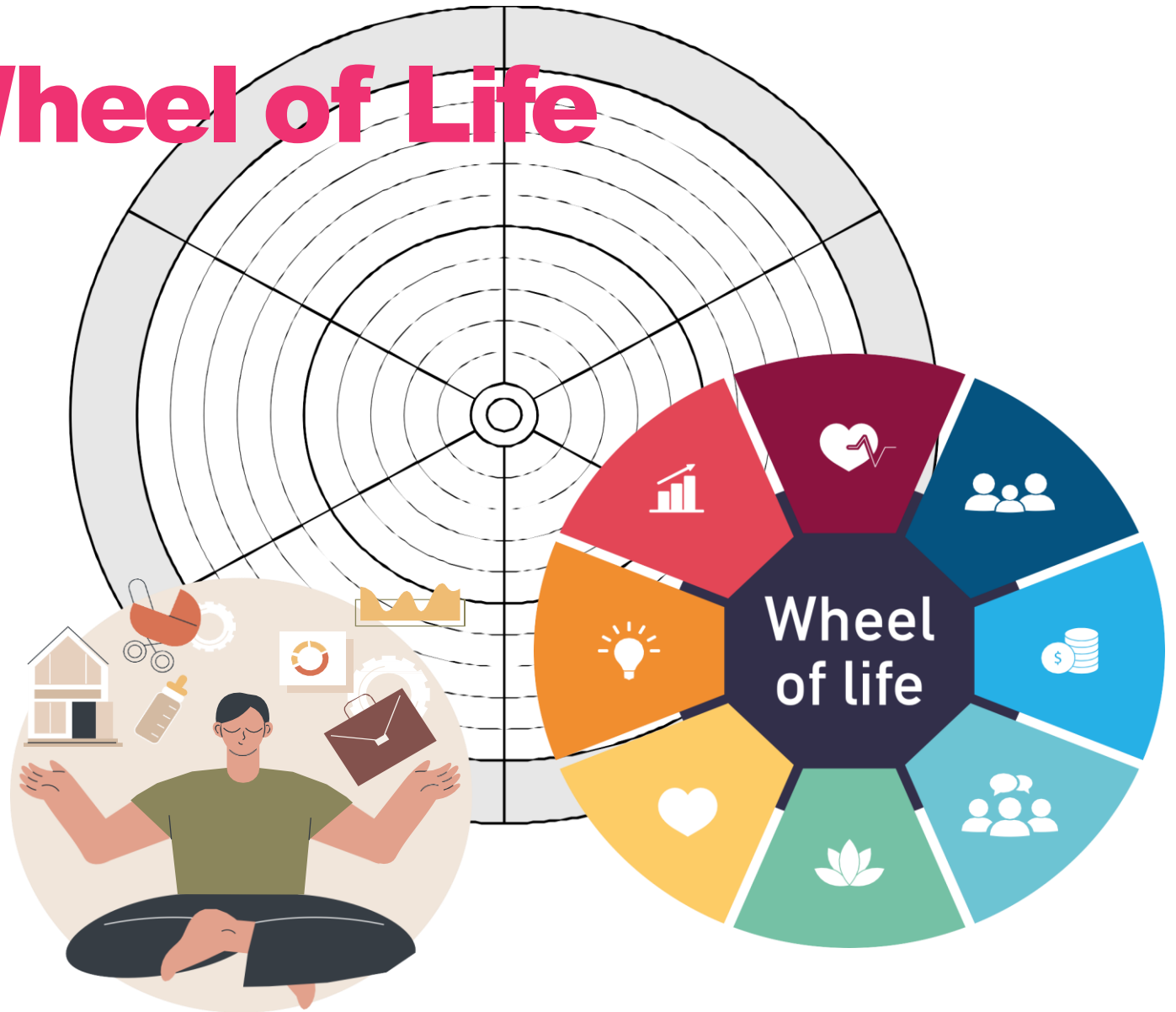

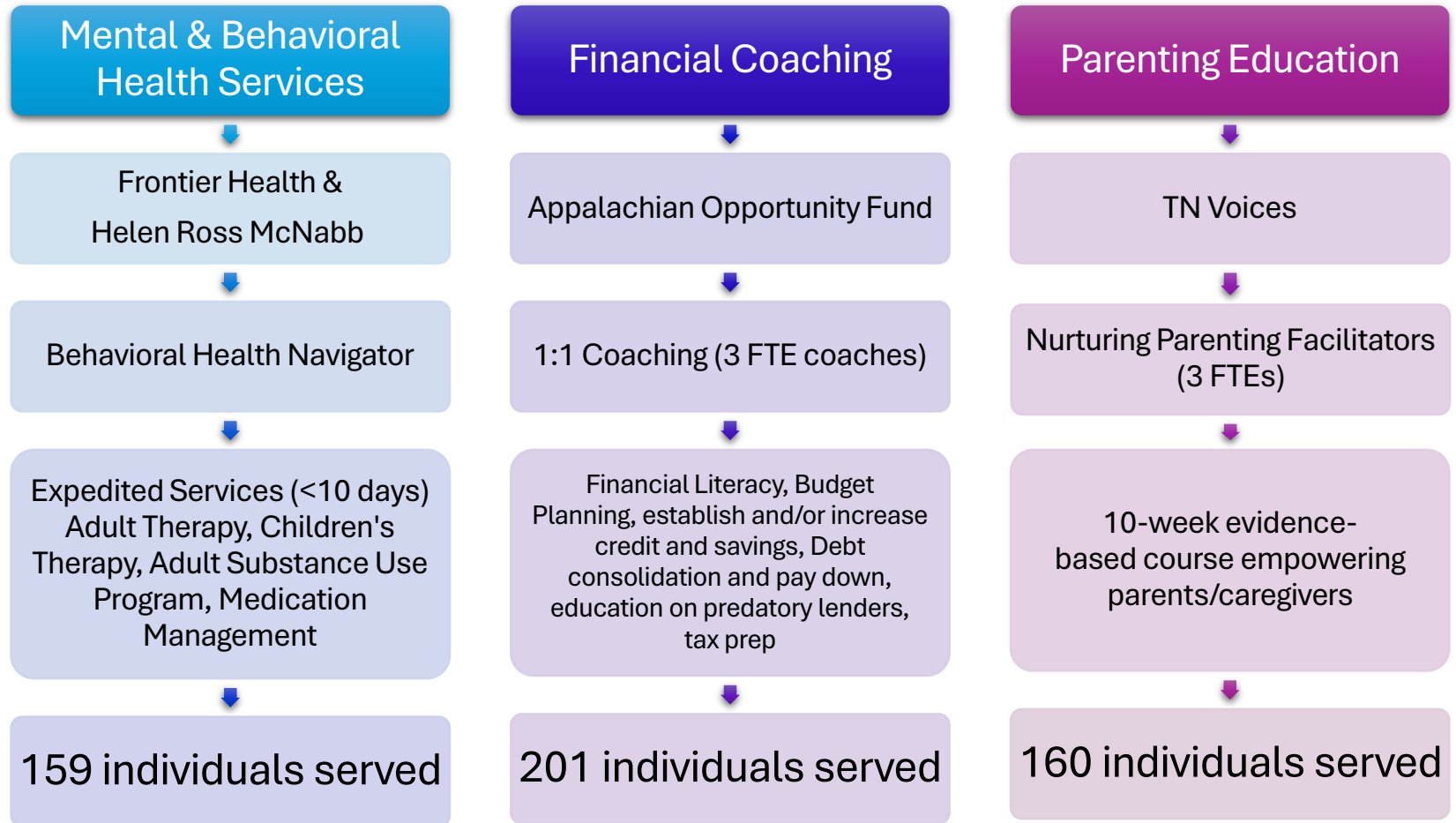


- 01 Be authentic, consistent, and transparent.

- 03 Actively listen to pinpoint areas on which to focus, taking small steps if necessary to increase personal and social capacity.

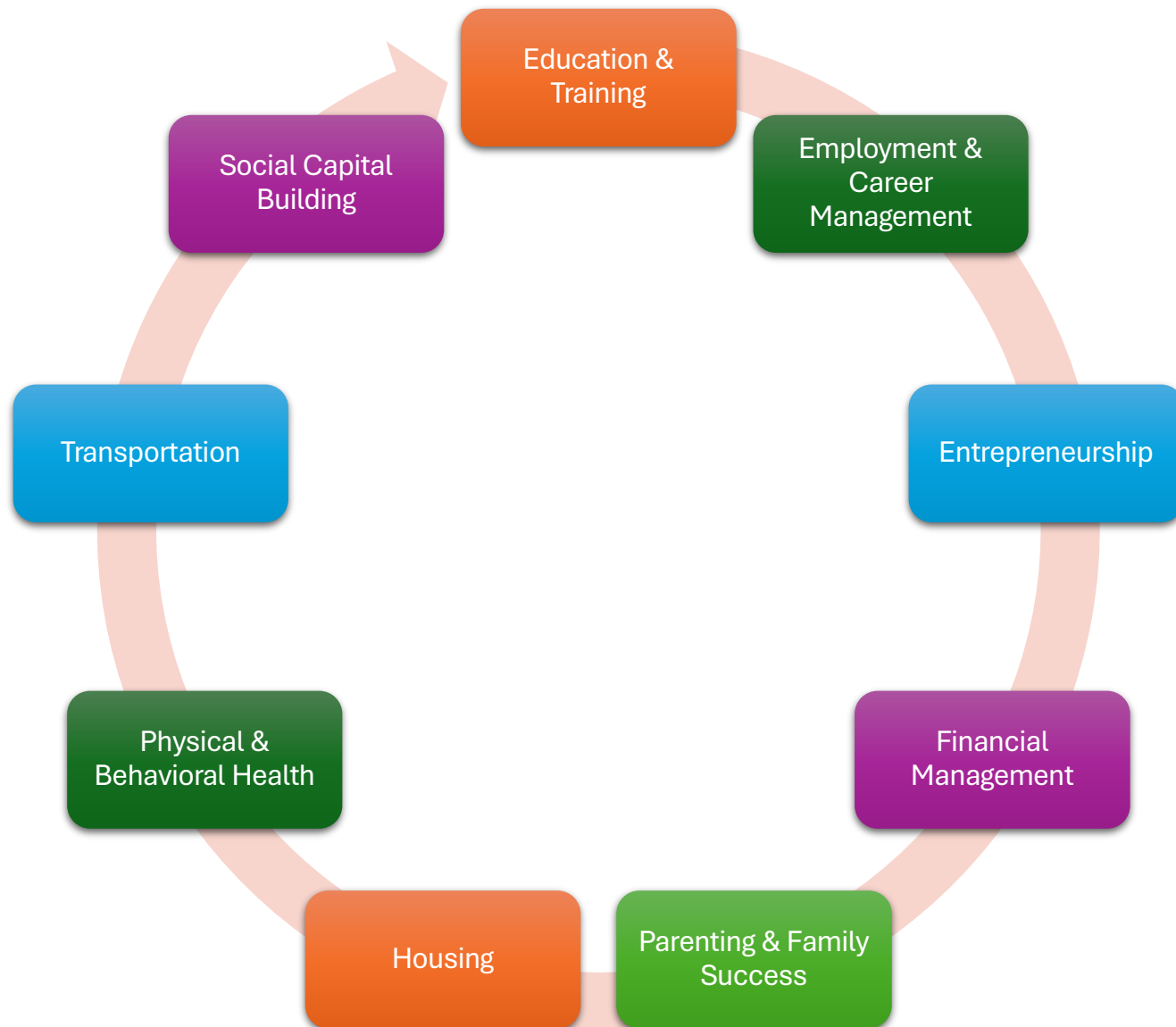

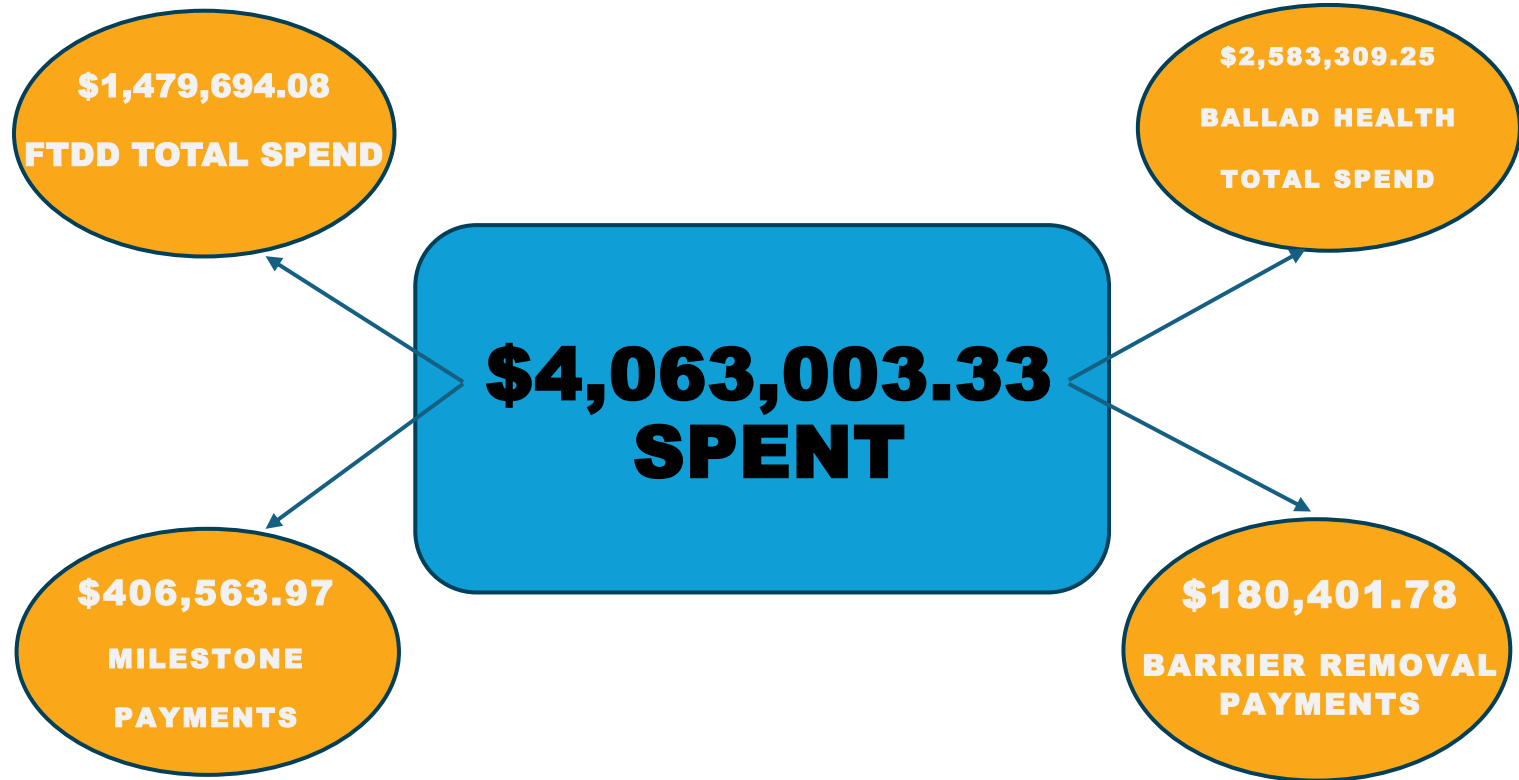

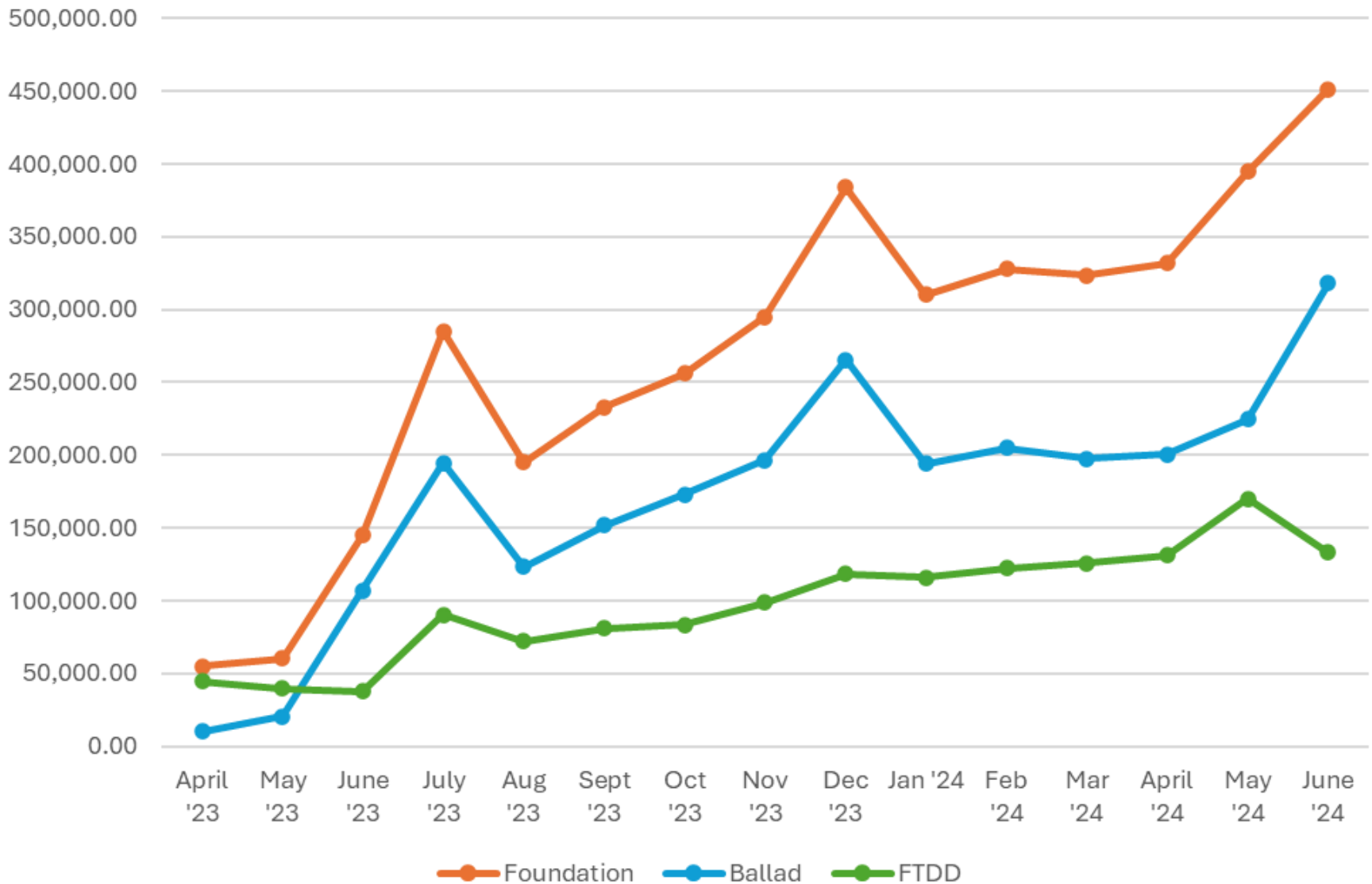
