ALPS Joins NYU Study of App for Caregivers of Older Adults

ALPS Adult Day Services is taking part in a national study using <u>a new smartphone app</u> to connect family caregivers and health providers around the care and wellbeing of older adults.

The app, <u>CareMobi</u>, was developed by researchers at NYU Rory Meyers College of Nursing to improve communication between an older adult's loved ones and their care team, including family members, doctors, and adult day center staff. Within the app, users can log important data including medications, vital signs, appointments, meals and appetite, and sleep, and then securely share this information so that everyone is on the same page about a person's day-to-day health.

"One of the most difficult issues we face is communicating with families. Their caregiving duties are allconsuming and the stress can be overwhelming," said Mahon J. Fritts, Chief Executive Officer of ALPS Adult Day Services. "Most of our family caregivers still work, and at ALPS, they've finally found a place they feel safe to leave their loved ones so they can concentrate on their work. The last thing they need is us calling them and adding to their stress."

"Adult day centers play an essential role in the wellbeing of older adults, but can feel disconnected from the rest of the health care system. CareMobi is designed to more seamlessly connect those caring for older adults in their communities where most of healthcare takes place. Our research will determine if app-based communication is a feasible approach to reducing fragmented care, and subsequent outcomes like emergency department visits and hospitalizations," said Tina Sadarangani, PhD, RN, ANP-C, GNP-BC, assistant professor at NYU Rory Meyers College of Nursing and the creator of CareMobi.

Ashley Pruitt, Chief Operating Officer of ALPS Adult Day Services and a licensed practical nurse, is spearheading the implementation of CareMobi at ALPS.

"ALPS is honored to be part of this study. We cannot thank Tina and the researchers at NYU enough for sharing this vital tool with us and helping to alleviate the stress of our family caregivers," added Fritts.
