

My Child Care Agency

A core purpose of Child Care Assistance is to promote parental choice and to empower parents to make their own decisions regarding child care services. Parents have the option to choose from the full range of eligible child care settings which includes a variety of center and home-based choices. The following information is designed to give you the tools to choose the care setting that best suits your family's needs.

Health and Safety Requirements

Child care agencies must follow rules designed to 1) protect children while under the care of the child care agency and 2) promote developmentally appropriate practices that enhance early learning and foster parental engagement. The basic requirements in these rules seek to maintain the adequate health, safety, and supervision of children while in a child care setting. Finding Information About My Child Care Agency

Specific information about a child care agency can be found by using the tools on the Find Child Care page on the DHS website. The Find Child Care page allows you to search for your child care agency by county, zip code, or your address. The page also includes a downloadable list of DHS licensed and DOE approved agencies in an Excel format. The list can be sorted and searched by any of the fields in the header (county, zip code, provider type, star rating, etc.).

Compliance History

When you look up a child care agency on the Find Child Care page you can also click on the "Compliance History" link to see the date of the last inspection and a record of any violations/complaints. Contact information for the Program Evaluator who monitors the agency is also available should you need more information about the facility.

Report Card and Star Quality Program

Every licensed child care agency must undergo an annual evaluation and post a report card of the results. Agencies are required to post their report card with their renewal license where parents can clearly see them. Agencies that earn a rating of one, two, or three stars can participate in the Star-Quality Child Care Program, a voluntary program that recognizes agencies who exceed minimum licensing standards. An agency must be open for one year before it is eligible to receive a star rating. You can review your agency's star rating on the Find Child Care page.
