

## **ABOUT POSITION**



Under general supervision, is responsible for human services program evaluation and consultative work of average to considerable difficulty; performs related work as required. The Operational Support Unit is a unit within the Division of Appeals and Hearings. This unit is responsible for offering assistance to any Unit with the Division of Appeals and Hearings. An employee in this class is responsible for reviewing and evaluating appeal issues and establishment of continuation of benefits for appellants. Review and evaluate appeal issues and continuation of benefits

## **RESPONSIBILITES**



Evaluate if appeal is valid (fair-hearable), timely, or duplicate.

- If appeal is non-fair hearable or untimely, sends to Conciliation Attorney.
- Determine timeliness for continuation/reinstatement of benefits.
- Continue/reinstate benefit eligibility per program guidelines.
- Identify issue(s) being appealed.
- Complete appeal creation in the Appeals Resolution Tracking System (ARTS).
- Review case to clarify issues.
- Make appropriate correction(s) in ARTS based on appeal issue.
- Attempt resolution of appeals without infringing on due process rights of client.

# QUALIFICATIONS

**Education and Experience:** Graduation from an accredited college or university with a bachelor's degree and experience equivalent to five years of full-time work in one or a combination of the following: social services, human services, education, accounting, auditing, and/or social services grant coordination.

**Substitution of Graduate Education for Experience**: Graduate course work from an accredited college or university in any liberal arts field, including but not limited to social sciences, mathematics, or statistics; education; public administration; and/or business may be substituted for the required experience, on a year-for-year basis, to a maximum of two years.

**Substitution of Experience for Education:** Additional experience in social services, human services, education, accounting, auditing, and/or social services grant coordination may substitute for the required education on a year for year basis to a maximum of four years (one year of experience is equivalent to 45 undergraduate quarter hours). Experience equivalent to three years in human services work as a state employee or as a individual under contract with the State of Tennessee.

Candidates must complete a criminal history disclosure form in a manner approved by the appointing authority; Agree to release all records involving their criminal history to the appointing authority; Supply a fingerprint sample prescribed by the TBI based criminal history records clerk.
