Code Ann. §33-3-607.
- 4. The Clerk give notice of the time and place of the hearing, the defendant's right to counsel, and the standards for commitment under Tenn. Code Ann. §33-6-502 to: (a) the defendant; (b) the chief officer of the institution where the defendant is; (c) the defendant's legal guardian or conservator; (d) legal custodian; (e) the spouse, parent, or adult next of kin if there is no guardian or conservator; and (f) the defendant's attorney.
