## **Opioid abuse (number served by TDMHSAS programs):**

This dashboard represents opioid use and abusers served among individuals ages 12 and older receiving TDMHSAS-funded substance abuse treatment and recovery services.

## **Recovery Court Service Areas:**

Recovery Courts are special courts willing to handle cases involving substance-abusing offenders through comprehensive supervision, drug testing, treatment services and immediate sanctions and incentives. This dashboard has a map that displays the number of Recovery Courts in a given county. The map can be filtered on judicial county and/or recovery court type. Below the map is a list of the judicial districts, judge names, county, and contact information. The list can be filtered by selecting a county on the map.

## **Recovery Congregation Locations:**

A certified recovery congregation must meet the following six criteria: 1. provide spiritual/pastoral support; 2. view addiction as a treatable disease, not a moral issue; 3. embrace and support people in recovery and walk with them on their journey; 4. provide a visible outreach in the community; 5. share recovery information; and 6. host recovery support groups. The map on this dashboard displays the number of certified recovery congregations by county. The map can be filtered by city and county. Below the map is a list of the congregations and their contact information.

**Behavioral Health Safety Net Services:**

Through contracts with 15 Community Mental Health Agencies across the state, the Behavioral Health Safety Net of TN (BHSN of TN) provides core behavioral health services to Tennesseans without insurance coverage that meets eligibility requirements. This dashboard gives a summary of rendered services and persons served for the last five fiscal years. The map displays the rate per 1,000 persons age 19+ serviced in each county of residence. A raw count can be found in the list on the right below the map. Below the map to the left is a statewide summary of some of the highest utilized services. Just below that is a statewide summary of the number of persons served.

**Behavioral Health Safety Net Locations:**

Through contracts with 15 Community Mental Health Agencies across the state, the Behavioral Health Safety Net of TN (BHSN of TN) provides core behavioral health services to Tennesseans without insurance coverage that meets eligibility requirements. This dashboard displays on a map the number of BHSN locations in a given county. The map can be filtered on county and/or provider region. Below the map is a list of the providers and their contact information. The list is filtered when any selection is made on the map.

**System of Care Locations:**

System of Care across Tennessee (SOCAT) focuses on children, youth, and young adults and their families. SOCAT utilizes the System of Care values and principles while empowering Tennessee families to work together with child-serving agencies as partners to guide the care. **Creating Homes Initiative:**

The Creating Homes Initiative (CHI) is a program created in August 2000 by current Commissioner Marie Williams in response to inadequate affordable housing options for persons with mental illness or co-occurring disorders in Tennessee. CHI seeks to assertively and strategically partner with local communities to educate, inform, and expand quality, safe, affordable, and permanent housing options to fulfill this need. This dashboard illustrates the dollars leveraged and housing opportunities the program provided for fiscal years 2000 through 2016.

**Crisis Services Assessments:**

Mental Health Crisis Services is a 24/7/365 response team for those who may be experiencing a mental health emergency. Face-to-face assessments are one of the services provided. This dashboard provides a summary of assessments completed by Mental Health Crisis Services in fiscal years 2014 through 2018. The rate used for mapping is calculated per 1,000 people in the county. Data in the rows are actual numbers per county of residence, per year.

**Crisis Stabilization Units (CSU):**

Crisis Stabilization Units (CSU) offer 24/7/365 intensive, short-term stabilization for someone experiencing a mental health emergency and is willing to receive services. The average length of stay in a CSU is three days. The service is free of charge. Crisis Stabilization Services can only be accessed by referral from Mobile Crisis Services or Crisis Walk-In Services. Mobile Crisis Services and Crisis Walk-In Services teams and locations can be found in the Crisis Services Centers dashboard.

**Crisis Services Centers:**

Crisis Walk-In Centers offer face-to-face, 24/7/365 evaluation for adults who are experiencing a mental health emergency. This dashboard presents the crisis mobile teams and the counties they serve. Contact information is provided in the list below the map.

**Psychiatric Hospitals (number of admissions):**

TDMHSAS operates four regional mental health institutes and contracts with three private psychiatric hospitals to provide inpatient mental health treatment services. This dashboard displays the number of admissions to regional mental health institutes and private psychiatric hospitals contracted by TDMHSAS. The map displays the number of admissions by county of residence. Fiscal years 2013 through 2017 can be selected.

**Psychiatric Hospitals (admission rate):**

TDMHSAS operates four regional mental health institutes and contracts with three private psychiatric hospitals to provide inpatient mental health treatment services. This dashboard illustrates the admission rate per 1,000 county population ages 18 and older. Fiscal year of admission 2013 through 2017 can be selected for view. Hovering over a county on the map will create a popup with the following information provided: admission fiscal year, planning council region, county name, population age 18+, total number of persons admitted, number of persons admitted to RMHI, number of persons admitted to private psychiatric hospitals, and admit rate.

**TDMHSAS Licensed Sites:**

TDMHSAS is the licensing authority for several different types of both residential and non-residential mental health and substances abuse service providers. The map on this dashboard displays the number of TDMHSAS-licensed Mental Health and Substance Abuse Sites by county. Hovering over a county, a pop-up will provide the number of sites in the county. The map can be filtered by city and/or licensure category. Below the map is a list of mental health and substance abuse service sites and their contact information. When the map is filtered, the list is then filtered, too. This information is updated daily and is subject to change.
