



 - Click on a county name in the Table of Contents to see hospital listings for that county; or
 - Click on the magnifying glass icon Q to open a pop-up window and type the word(s) you want to search for. If your search highlights multiple references, you can navigate from one reference to another by clicking on the up and down symbols in the search window or by pressing the "enter" key on your keyboard; or
 - You can simply scroll through the document

- November 30, 2023: <u>Cigna and Vanderbilt University Medical Center in Middle Tennessee</u> are currently in negotiations. <u>If</u> Cigna and Vanderbilt cannot reach an agreement, Vanderbilt hospitals and affiliated providers will be leaving the Cigna LocalPlus and Cigna OAP networks effective January 1, 2024.  - UPDATED December 8, 2023: Vanderbilt University Medical Center and Cigna have reached an agreement.
 The facilities listed in the chart below will remain in Cigna LocalPlus and Cigna Open Access Plus networks.

- OCTOBER 20, 2023: <u>BCBST and Ballad Health System in East Tennessee</u> are in negotiations. Ballad Health System
 hospitals and affiliated providers will be leaving BCBS Network S and BCBS Network P effective January 1, 2024 if
 Ballad and BCBS cannot reach an agreement.
 - UPDATED November 21, 2023: Ballad Health System and BCBS have reached an agreement. The Ballad facilities listed on the page iii, will remain in both networks. See chart on page iii.
- OCTOBER 20, 2023: <u>BCBST and Maury Regional Health System in Middle Tennessee</u> are also in negotiations. Maury Regional Health System hospitals and affiliated providers will be leaving BCBS Network S and BCBS Network P effective February 1, 2024 if they cannot reach an agreement.
 - UPDATED November 17, 2023: Maury Regional Health System and BCBS have reached an agreement. Maury Regional Medical Center in Columbia and Marshall County Medical Center in Lewisburg will remain in BCBS Network S and BCBS Network P. Wayne Medical Center in Waynesboro, also a part of this system, will remain in both networks. See chart on page iii.
