6 Vice Chairman John Hie, Commissioner Herbert H.
7 Hilliard, Commissioner Robin L. Morrison (Via
8 Telephone), Commissioner Clay R. Good, Commissioner
9 Kenneth C. Hill (Via Telephone), Commissioner David
10 Crowell, when the following proceedings were had,
11 to-wit:)

12 COMMISSIONER HILLIARD: Good morning.
13 You may be seated.

14 Good morning. An announcement before
15 we start. I've got good news and bad news. The good
16 news is starting today, we have a new chairperson and
17 new vice chairperson. David Jones will be the new
18 chairperson effective as -- effective today. And John
19 Hie will be the vice chairperson.

20 The bad news is you don't get to hear
21 from me anymore. But -- and in case you didn't know,
22 we usually rotate -- we rotate every two years the
23 chairperson and vice chairperson. You've probably seen
24 my face a little more in the last two or three years
25 than you probably want to, but that's the change and
