## **Instructions: Application for Certificate of Registration for Beer Wholesalers**

Every beer wholesaler distributing beer in Tennessee must register each location with the Department of Revenue before beginning business and must renew its registration each year. The registration or renewal must include an annual registration fee of **\$20**. Beer is defined as any alcoholic beverage, other than wine, that has an alcohol content of 8 percent or less by weight.

In addition to the registration fee, every Tennessee beer wholesaler must furnish a bond payable to the Department based on its highest month's sales of the previous year, or if this is a new registration, based on its estimated sales, up to \$10,000. In no event is the bond required to exceed \$10,000.

The application along with the appropriate fee payment from Line 3 and the bond amount is due within 20 days following the beginning of business and on or before January 20 of each subsequent year. ### **Application**

Complete the form with the wholesaler's business information.

- Line 1: Enter **\$20**.
- Line 2: Penalty is calculated at a rate of \$5 a month, or portion thereof, that an application is delinquent, up to a maximum of \$20. If your application is filed after January 20 or more than 20 days after commencement of business, whichever is applicable, enter the appropriate penalty amount.
- Line 3: Add Lines 1 and 2.
