

## LOW SPEED VEHICLES

Vehicle Title and Registration Notice

September 2008



## Highlights

- *Low speed vehicles may be titled and registered in Tennessee*

**INTRODUCTION**

This notice is intended to provide county clerks and the general public with information concerning the titling and registering of low speed vehicles.

**Low speed vehicles that meet certain statutory requirements may be titled and registered in Tennessee for use on roads with a speed limit of thirty-five miles per hour (35 mph) or less. Generally, golf carts are excluded, unless they are specifically designed and manufactured for on road use or have been modified to meet all of the statutory requirements and safety standards outlined in this notice. Page two of this notice discusses golf carts in more detail.**

**DISCUSSION**

Tenn. Code Ann. §§ 55-1-103, 55-4-111, 55-8-101, 55-8-191, and 55-50-102 provide that low speed vehicles may be titled and registered in Tennessee if they meet the requirements outlined in the law. A low speed vehicle is defined in Tenn. Code Ann. § 55-1-122, as follows:

- *"Low speed" vehicle defined*

"Low speed vehicle" means any four-wheeled electric or gasoline vehicle, excluding golf carts, whose top speed is greater than twenty miles per hour (20 mph), but not greater than twenty-five miles per hour (25 mph), including neighborhood electric vehicles. Low speed vehicles must comply with the standards in 49 CFR 571.500.

- *Proper safety equipment is required*

The standard contained in 49 CFR 571.500 (Code of Federal Regulations) requires low speed vehicles to have basic safety equipment, including head lamps, stop lamps, front and rear turn signal lamps, tail lamps, reflectors (one red on each side near the rear and one red on the back), parking brake, one exterior mirror mounted on the driver's side of the vehicle and one additional mirror on the passenger side or an interior mirror, a windshield meeting the standards outlined in 49 CFR 571.205, seat belts (type 1 or 2) located at each designated seating position, and a vehicle identification number (VIN) that conforms to provisions outlined in 49 CFR 565. The purpose of this standard is to ensure that low speed vehicles operated on the public streets, roads, and highways are equipped with the minimum motor vehicle equipment appropriate for motor vehicle safety.

- *Special laws govern the use of low speed vehicles on Tennessee's roads*

**Important Information:**

The laws regarding the operation of low speed vehicles on Tennessee's roads are contained in Tenn. Code Ann. § 55-8-191. Low speed vehicles can only be operated on streets where the posted speed limit is thirty-five miles per hour (35 mph) or less. A low speed vehicle is permitted to cross streets that exceed this thirty-five mile per hour limit.

Owners and operators of low speed vehicles, including modified golf carts, are subject to the requirements outlined in Tenn. Code Ann. § 55-8-191 regarding the proper operation of these vehicles on Tennessee's roads and must have a Class D driver license in their possession when operating the vehicle.

In the interest of safety, local county government entities or the Tennessee Department of Transportation may prohibit the operation of low speed vehicles on any road in its jurisdiction.

- *A low speed affidavit form is required when there is no MSO indicating the vehicle is a low speed vehicle*

To register a low speed vehicle, designed and manufactured for on road use, applicants should provide to their local county clerk's office a copy of the vehicle's MSO (manufacturer's statement of origin), as proof that the vehicle meets all statutory requirements and safety standards, along with the traditional documentation required for vehicle registration. Applicants must submit the low speed vehicle affidavit form (RV-F1314301) with their registration application when there is no MSO indicating the vehicle is a low speed vehicle. ### **Golf Carts**

- *Unmodified golf carts may not be registered and titled in Tennessee*

Traditional golf carts, as defined by Tenn. Code Ann. § 55-1-123, may not be titled and registered for on road use, unless modified to meet all of the low or medium speed vehicle requirements in Tennessee law and the federal safety standards contained in 49 CFR 571.500. Traditional golf carts are defined in Tenn. Code Ann. § 55-1-123 as follows:

"Golf cart means a motor vehicle that is designed and manufactured for operation on a golf course for sporting or recreational purposes and that is not capable of exceeding speeds of twenty miles per hour (20 mph)."

- *Golf carts can be modified to meet the strict specifications of low speed vehicles, allowing them to be titled and registered*

A golf cart that is designed and manufactured for on road use, or is modified to meet all of the low or medium speed vehicle requirements and federal safety standards does not meet the definition of a traditional golf cart, as outlined in Tenn. Code Ann. § 55-1-123. Since this vehicle is not a golf cart as defined under Tennessee law, the vehicle may be registered as a low or medium speed vehicle if all requirements are met to be a low or medium speed vehicle.

- *Assistance is available from Revenue if you have questions*

Individuals modifying a traditional golf cart to meet low speed vehicle requirements must submit a low speed affidavit form (RV-F1314301) that certifies the vehicle has been sufficiently modified to meet all low speed vehicle requirements. The affidavit must be submitted with the registration application as a condition of registration. Clerks are authorized to title and register these vehicles as low speed vehicles if all documentation requirements are met.
