TNTAP = Tennessee Taxpayer Access Point



Two Step Verification

- Most users already have two-step verification set up.
- If two-step verification is not set up, the system will prompt you to set it up when you log in.
- This is to keep your account secure. The code will be available through the authentication app, or sent to the email or cell phone number you provided.

Protect your TNTAP profile with two-step verification

Two-step verification is used to better protect your account and TNTAP profile. Once setup you'll be asked to provide a unique security code to verify your identity each time you log in.

Authentication App

Use an authentication app, such as Google Authenticator, to get security codes.

Text Message

Receive security codes by text message.

[Add Phone](#)

If you switch cell phone providers, delete the existing number and add the new provider.

Email

Receive security codes by email.

[Add Email](#)

To stop receiving email messages with your security code, click the X to delete the email address.



Email

- If you choose to receive your code through email it will look like the image below.
- If you did not receive the email, check your **Spam** folder.



TIP: If your TNTAP session is still open, copy the code from your email.



Authentication

- Return to your open TNTAP session and enter the code from the email.
- Click **Confirm** to continue.




