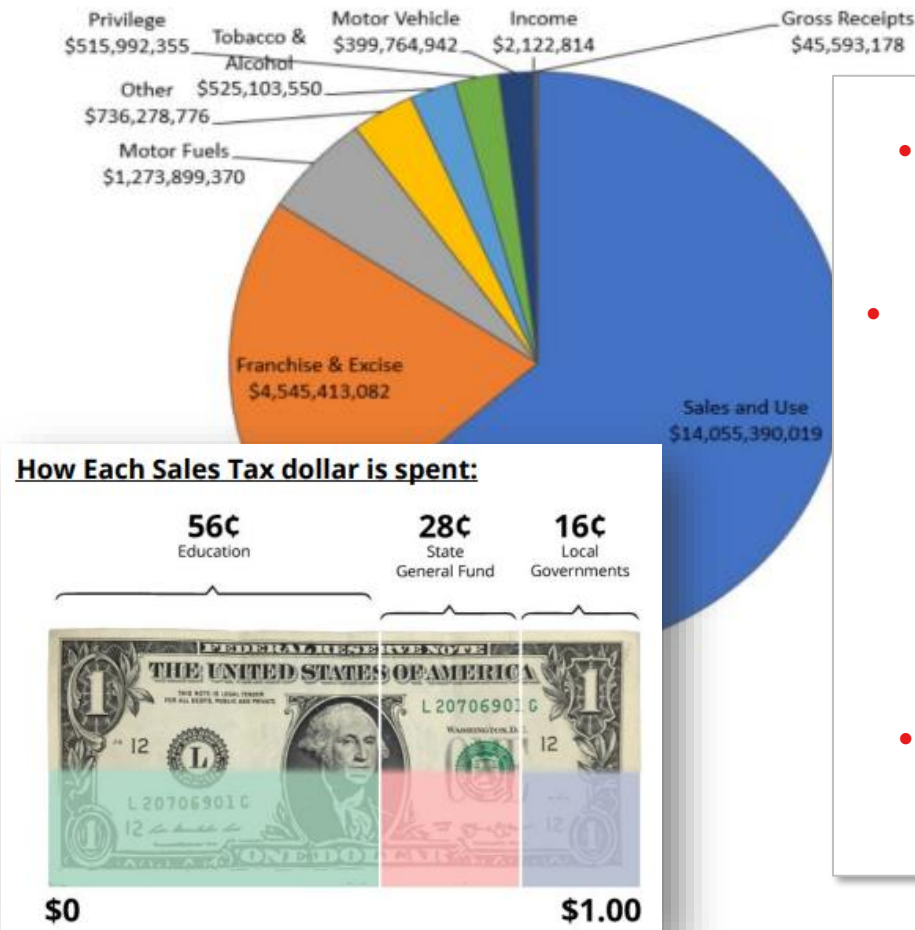

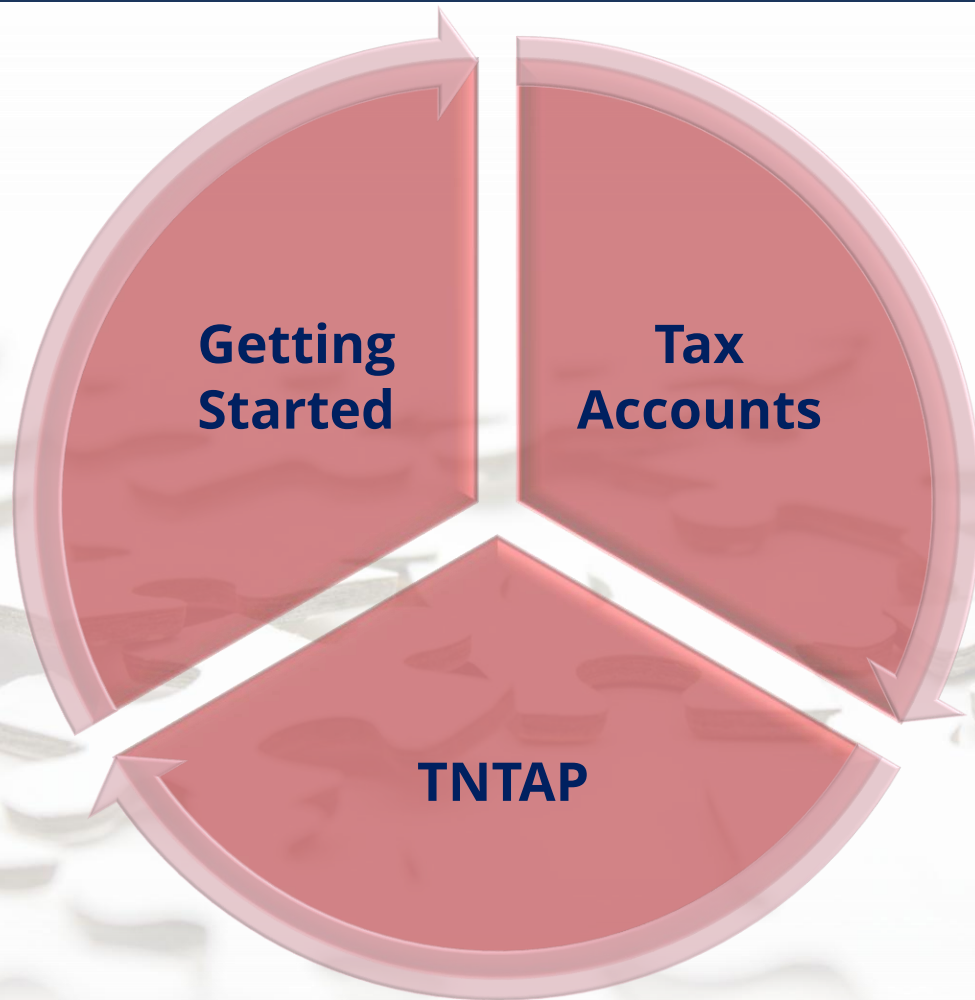

Licenses Permits and More!

What	Where	Required for
Business License	County/City Clerks office	Most businesses with few exceptions (more info later!)
Charter/Business Registration	TN Secretary of State	Partnerships, corporations, LLCs, business trusts
Federal Employee Identification Number	Internal Revenue Service (IRS)	Partnerships, corporations, LLCs, business trusts AND all businesses with employees regardless of structure
Unemployment Insurance	TN Dept. of Labor & Workforce Development	All businesses with employees/payroll
Professional License	TN Dept. of Commerce & Insurance	Certain professions (contractors, cosmetologists, insurance agents, etc.)
Alcohol License	TABC	Sales of alcoholic beverages for consumption on the premises
Tax Accounts	TN Dept. of Revenue	Most businesses with few exceptions (more info later!)

Common TN Taxes for Businesses

TAX TYPE	APPLIES TO
Sales Tax	OVER \$4800 ANNUAL RETAIL TPP SALES AND/OR OVER \$1200 ANNUAL TAXABLE SERVICES
Business Tax	MOST BUSINESSES (ENTITY DOESN'T MATTER) WITH \$100K+ IN ANNUAL RECEIPTS . RENEWS ANNUAL STANDARD BUSINESS LICENSE ISSUED BY LOCAL CLERK(S). [MINIMAL LICENSE REQUIRED FOR UNDER \$100K, RENEWABLE ANNUALLY AT WITH LOCAL CLERK]
F&E Tax	BUSINESSES REQUIRED TO REGISTER WITH TN SOS (CORPORATIONS, LLCs , ETC. SOLE PROPS DO NOT OWE)

Sales Tax Basics

Applies to retailers with **over \$4800 annually in TPP** and/or providers of **over \$1200 annually in taxable services**

TAXABLE	RATE	WHO PAYS	FILING FREQUENCY	NOTES
"STUFF" (TPP), SOME SERVICES	LOCATION BASED. STATE + LOCAL RATE. SOME SPECIAL RATES	BUSINESS COLLECTS FROM BUYER AND REMITTS	ANNUALLY, QUARTERLY, OR MONTHLY (DEPENDANT ON SALES AMT)	LOTS OF EXEMPTIONS. RESALE CERTIFICATE

Business Tax Basics

Applies to most businesses (entity doesn't matter) with **\$100k+ in annual gross receipts**. Renews annual STANDARD BUSINESS LICENSE *issued by local clerk(s)*.
[minimal license required for under \$100k, renewable annually at with local clerk]

SOS (Corporations, LLCs, etc.
[SOLE PROPS DO NOT OWE]**

Liquor-by-the-Drink (LBD) Basics

Applies to businesses selling "alcohol and wine" by the drink for consumption on premise (beer handed locally).

TAXIBLE	RATE	WHO PAYS	FILING FREQUENCY	NOTES
ALCOHOL AND WINE	15%	CUSTOMERS PAY, BUSINESS REMIT	MONTHLY	CLOSELY TIES TO ABC LICENSE

GENERAL TAX ACCOUNT INFORMATION

- Delinquencies
 - Penalties and interest apply to any deficient/delinquent payments.
 - A penalty of 5% of the unpaid amount is added for each month (or partial month) that a payment is delinquent or deficient, up to a maximum of 25%.
 - Interest is computed at the [current rate of interest](#).
- Collections will be made on any taxes not filed/paid.
- If taxes are overpaid, refunds or credits can be issued.

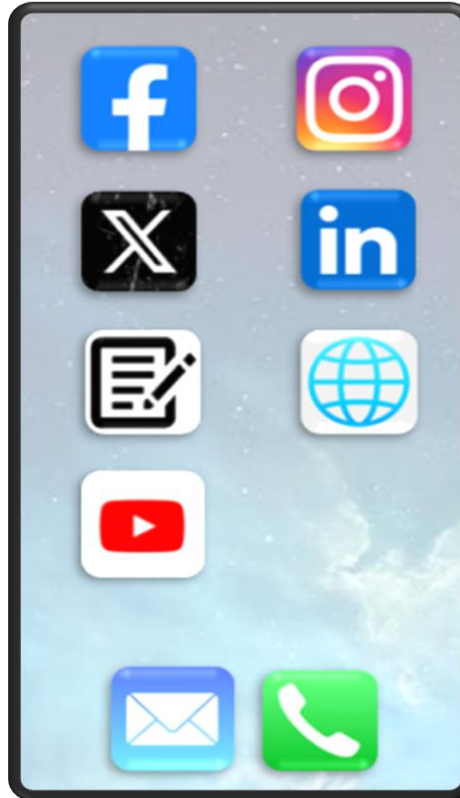
