Required reinstatement fees are set by law and cannot be waived.

If an individual has submitted all reinstatement requirements from courts, insurance etc. and only has an outstanding fee balance with the TDOS, the individual may enter a payment plan at Driver License Reinstatement Office or may request to have payment plan mailed.

Bankruptcy: The reinstatement fee can be filed under a Chapter 13 bankruptcy. If the bankruptcy is dismissed, action will be taken on the individual, including accruing fees.

SR-22 FEE: The fee is required when an individual has to file SR-22 and charged when reinstating. If new violations are added to the record requiring SR-22, after an SR-22 fee has been paid, the fee is assessed again.

SURRENDER FEE: An individual is sent a notice of revocation/suspension allowing 20 days to surrender their driver license and/or vehicle tags/registration. If the individual no longer has possession of license, they should notify our department in writing. If individual does not surrender license or notify our department within the 20 days allowed, then a \$75 surrender fee will be applied to the reinstatement requirements. Only one \$75 fee is required at any one time of reinstatement.
