Before completing the FY 2021 Homeland Security Grant Program (HSGP) Investment Justification (IJ) proposals, please read this Instructions Page and the Notice of Funding Opportunity (NOFO) – specifically, *HSGP & UASI Funding Priorities* and the *Allowable Program Activities* sections. Information specific to the grant criteria and guidelines for your investments is contained within those sections. Also, please ensure your projects are in alignment with the National and State priorities. Applications must be complete and correct in order to be approved.

**PURPOSE:** The purpose of this application is to build the State's Investment Justification (IJ) for FY 2021 homeland security grant funds from the Department of Homeland Security/FEMA. DHS has mandated that applicants meet a required minimum spending in specific National Priority areas. This IJ outlines how the funds will be spent and in what areas. Should the applicant not address these requirements adequately, as deemed by DHS/FEMA, funding may be forfeited to another state. Having a strong, concise, and complete IJ ensures Tennessee will receive the initial proposed amount without delay and positions us for possible additional funding from applicants that do not meet DHS/FEMA IJ requirements.

Investment Description – Please be clear, concide and complete. When completing the Investment Description, please articulate what Core Capabilities your investments recaddressing (found in the NOFO under SHSP and UASI Funding Priorities); what needs or gaps your investments are addressing (e.g. Fraining, Equipment & Capital Expenses, Awareness Campaigns, Planning, Exercises, etc., also found under the SHSP and UASI Funding riorities); who will receive/manage the investment; and keep the investments in alignment with the Priority you selected. Lastly, please limit the number of individual county investments and focus on District wide investments - investments will be evaluated by FEMA/DHS personnel for effectiveness, adherence to programmatic guidelines, fiscal soundness, implementation timeliness and completeness.
