2) Chancellor Morgan presented a request for approval of a revision in scope and estimated project cost from \$13,600,000.00 to \$16,600,000.00 (\$3,000,000.00 increase), allocation of funding, and authorization to proceed with a previously approved planning project in accordance with Public Chapter No. 1108, Public Acts 2010 for **Community College Special Capital Outlay Program**, and authorization to change the designer from the joint venture of Habiterra Architecture/McGehee Nicholson Burke, to the single firm of McGehee Nicholson Burke, due to Habiterra closing their Tennessee office.

Discussion ensued regarding the "unfunded" amount listed for the project. Chancellor Morgan responded that, with the dollars in hand, they believe they can meet the campus' needs. He said as they continue to raise money for this project, they can continue to phase in additional work, which would be brought back to the SBC for approval. Comptroller Wilson confirmed that they were not approving the unfunded amount. Treasurer Lillard expressed concern about setting a precedence with showing an unfunded amount, and didn't understand the reason for proceeding in that manner. Chancellor Morgan replied that it didn't happen often and that it allowed them to work toward a project within that size. Vice Chancellor David Gregory was recognized. He stated that this project received initial planning funds two years ago and this gives them the ability to see if they can raise additional dollars for the project. Either way, he said, they will come back to the SBC for approval. Treasurer Lillard asked if they were designing the unfunded portion, and questioned what the unfunded portion gets them. Mr. Gregory responded that they could manage the project either way. Treasurer Lillard made a motion to approve the request with the deletion of the unfunded line and with the language clarified for the \$3 million increase. The motion was seconded and passed without objection.

He stated that the next phase would involve moving Motor Vehicle Management to the site, although a cost has yet to be determined for that piece. Treasurer Lillard expressed his concerns about the project and asked how much they paid for the building. Assistant Commissioner Dottie Hagood responded that they paid \$11.8 million, but also charged Piedmont Gas rent for several months. Treasurer Lillard made a motion to refer the matter to the Subcommittee, with authority to act, with the understanding that staff will get with Real Property Administration to discuss this project. He said they need to clearly understand where they are going with this project. Secretary Hargett said he wanted them to look at it and see what they could have done differently. Ms. Hagood responded that if they ever purchase another building, they will get it commissioned before they move in. Commissioner Morrow agreed with all the comments and stated that one of the pushes on the front end was to vacate the Department of Transportation building on Charlotte Avenue. After further discussion, Treasurer Lillard's motion was seconded, and passed without objection.
