1) Dr. Petersen presented a request for approval to issue a Request for Proposals for the development of a revised master plan and architectural guidelines for the Cherokee Campus at the University of Tennessee. Treasurer Sims said it was his understanding the master plans that have been done are now dated and unsuitable for that property, and that the University of Tennessee is not able to fund another master plan. He said that a private group has offered to fund the master plan revision and design guideline development. He also noted that the only impact this will have on the other architect and designer teams already selected to do projects at the Cherokee Campus is that they will have to adhere to the new guidelines and master plan and that designers for buildings will not be selected by an RFP process but by the Commission's customary selection process. Further, Mr. Sims described the project as a "one-off" and noted that it does not change the way the State or the Commission will do plans or buildings in the future or the way architects, designers or other parties are assigned to projects. He added that this would be a master plan that will come back for approval by THEC and SBC. He said he knew there was a sense of urgency to get this done. He said the RFP should follow the State's model, and the closer they stick to that model, the faster it will go. He added that UT will need to work with SBC staff and the process. He made a motion to send the request to the Subcommittee with authority to act with the understanding that they adhere to the outline he discussed. Secretary of State Darnell said that the staff will have to work through the funding and RFP issues before the Subcommittee is comfortable. Dr. Petersen commented that the site is a once in a lifetime opportunity. He said he appreciated the SBC's support and agreed that they will work with staff. The Commission then approved Treasurer Sims' motion as presented.

TENNESSEE HERITAGE CONSERVATION TRUST FUND

Mr. Fitts presented a report by the **Tennessee Heritage Conservation Trust Fund Board of Trustees** as required by T.C.A. 11-7-101, et. seq., which states that the THCTF Board is responsible for "reporting to the State Building Commission the acquisition of conservation easements and reversionary interests by the trust fund and the acquisition of any interest in real property by a non-state public agency, or a nonprofit organization using grant funds received from the trust fund." According to the report, there has been no activity within the fund for the first two quarters of 2008. The fund balance is \$5,439,125.99 including accumulated interest. The Commission accepted the report as presented.

NATIONAL CIVIL RIGHTS MUSEUM, MEMPHIS, TENNESSEE

Mr. Fitts informed the Commission that a Facilities Assessment Report had been completed in accordance with the Lease Agreement between the State and the Lorraine Civil Rights Museum Foundation, and that copies had been mailed to them. He distributed a memo detailing specific maintenance items in the report stating that the majority of the maintenance issues were funded as projects for, or grants to, the NCRM. Discussion ensued regarding the funding sources for the various maintenance projects at the Museum. Treasurer Sims stated that the grant works on a reimbursement basis, rather than receiving a lump sum. Commissioner Goetz asked what the source of funding was for major maintenance needs and how much was the Foundation funding. Comptroller Morgan said the Foundation is responsible for routine maintenance and operating costs—not major maintenance. He said the cost for operating the facility is far greater than what the State is funding. He added that the facility survey was established during the negotiations for the lease. After discussion, the Commission accepted the report.
