Lieutenant Governor Ramsey called the meeting to order at 11:08 a.m. Treasurer Lillard began a discussion regarding the **Mechanical/Electrical Upgrade** project (SBC No. 529/005-01-2005) at the State Capitol following a memo he received from Real Property Administration. He stated that the Commission approved moving the people around, but that was all, and asked that they receive a presentation regarding the project.

Commissioner Goetz stated that it was his understanding that a very complex series of things have to occur around the HVAC system replacement, which involved a sequence of moves to accommodate the work. Mr. Fitts stated that Real Property Administration is trying to identify a contractor through the Construction Manager process. He noted that a contractor can be very valuable in developing the schedule and that getting a contractor on board will be an aid in the overall design and scheduling. He said that the planning dollars will be sufficient to fund the contractor's preconstruction services. However, the project will come back to the SBC as to the identification of the CM and proceeding with the contract.

Comptroller Wilson read an email from Dottie Hagood and said he didn't think it sounded like what Mr. Fitts was outlining. Mr. Fitts responded that the work involves all of the SBC members and the incoming Governor. He said everyone will have to be on board and this RFP is a tool to help in that process. Secretary Hargett questioned the "on time" reference in Ms. Hagood's email.

Nick DePalma, project manager with Real Property Administration, was recognized. He stated that Ms. Hagood's intent was to try to establish points of contact to begin to describe what this plan entails. He said that they have a planning proposal regarding where personnel would reside during construction of the project between sessions in 2011. He said they have made some assumptions and would like to confirm those with the Legislative and Executive branches. He said they need general consensus and have a 7-month schedule to do it and need the assistance of the CM to advise them of the cost and schedule. He said that funding for the project has not been fully allocated and that they are in a planning stage where it is necessary to interface with the Capitol offices.

Treasurer Lillard asked that there be a presentation to the SBC or Subcommittee, and he would like to have a discussion of the overall plan of where this fits into the State's plan. Commissioner Goetz said that procurement of the CM is about getting the planning started and determine what is even feasible. Lieutenant Governor Ramsey asked if this project includes the Legislative Plaza, and Mr. DePalma replied that the planning project includes the Legislative Plaza and War Memorial Building, but it would not be feasible to do all three buildings in one year and would need to be phased. After discussion, it was agreed that an update on the project would be presented to the Executive Subcommittee at their next meeting.
