He added that a process needed to be developed for bid protests and that he would be working on that. Based on Mr. Fitts' recommendation, the Commission approved the request as presented.

EXECUTIVE RESIDENCE, NASHVILLE, TENNESSEE

- 1) Mr. Fitts presented a request for approval of a revision in scope and estimated project cost from \$1,415,000.00 to \$5,740,000.00 (\$4,325,000.00 increase) of a project for **Maintenance, Renovations & Improvements** at the Executive Residence, Nashville, and approval to fully plan the additional scope portions of the project within the available funds. He stated that this action will allow for the full planning of the complete maintenance repair and upgrades at the Residence and will include ADA improvements as well as address environmental deficiencies. He said it will allow for an approximately \$5.1 project to be implemented in addition to the work that is being completed under the original project. He said it was anticipated that the Tennessee Executive Residence Preservation Foundation II and other private donors will contribute 60% - 80 % of the \$5.1 estimated costs through gifts and in-kind contributions. Mr. Fitts acknowledged the First Lady, Andrea Conte, as the real catalyst and inspiration for the project. The Commission recognized and welcomed Ms. Conte and commented that her attendance at a State Building Commission meeting was the first for a First Lady.

Ms. Conte thanked the Commission for the opportunity to appear before the Commission. She listed various items that badly needed attention at the Residence and emphasized the big infrastructure problems. She said that the Foundation was in place and functioning and that they have already set up a finance committee that is bi-partisan. She stated that they have spoken with past Governors and First Ladies and they have all been supportive. Ms. Conte said they were not going into debt to do the work and would not proceed unless the money was available. She mentioned that excess inaugural funds were used to pay for the new roof, which is essentially complete. She added that this project was a key priority for her this year and hoped that the request before them met with their approval.

Speaker Naifeh stated that he went on the tour of the Residence and assured everyone that it needs everything the First Lady asked for, and then some. He said he hoped that this would include the additional building. Mr. Fitts responded that it would not be included in this request, but was included in the master plan. Speaker Naifeh said the Residence is in dire need of repair and anyone who has been critical of the Governor and First Lady for not moving into the Residence should see it. He said that the perfect opportunity has presented itself at this time because they have their home in Nashville. He moved to expedite the request as presented. The motion was properly seconded and passed without objection.

SPECIAL ITEM

- 1) Mr. Fitts presented a request for approval of an application submitted by the City of Sevierville to establish a Tourism Development Zone in order to use certain incremental increases in State and local sales and use tax revenue to finance qualified public use facilities based on the standards by the "Convention Center and Tourism Development Act of 1998". Larry Kirk was recognized and explained the three-step process for establishment of a Tourism Development Zone. He informed the Commission that several members from the City of Sevierville and Legislative delegation were present to answer any questions. Speaker Naifeh commented that he understood how this was to be financed but asked what would happen if that does not occur. Doug Bishop, City of Sevierville, was recognized and replied that they have several backup plans. Mr. Bishop said they have the private developers at the table and it will be in a horse race with them to get their projects finished first. He said the private development partners will be ready to work concurrently with them instead of following them. After general discussion, the Commission approved the request as presented.

SBC BYLAWS, POLICY AND PROCEDURES

- 1) The Commission approved the following revision to the *State Building Commission By-Laws, Policy and Procedures* to reflect current initiatives in diversity of contracting by deleting the existing paragraph 5.03 below and substituting the following:

(EXISTING)

5.03 MINORITY PARTICIPATION IN STATE BUILDING COMMISSION PROJECTS

It is the express desire of the State Building Commission that all bidders actively seek participation by minority-owned businesses in the construction, demolition or renovation of State projects under jurisdiction of the Commission. Although the efforts by any bidder to meet this requirement will not be a factor in evaluation of bids, the State will require the successful bidder to report to the State the names and amounts of contracts entered into with minority-owned businesses on State projects in order for the State to collect data on such participation.

It is a policy of the Commission that the above statement accompany the bidding documents for State projects under the jurisdiction of the Commission. [*SBC Meeting Minutes 3/10/94*]

5.03 MINORITY PARTICIPATION IN STATE BUILDING COMMISSION PROJECTS

It is the express desire of the State Building Commission to include an emphasis on diversity in its contractual relationships with contractors for the construction, demolition or renovation of State projects under the jurisdiction of the Commission. The Commission acknowledges that firms who demonstrate and embrace diversity within their programs and policies are assisting the State in achieving its goals in building a more reflective marketplace of the community within this state.

- A. It is a policy of the State Building Commission that the above statement accompany the bidding or proposal documents for State projects under the jurisdiction of the Commission.
- B. It is a requirement of all successful bidders or proposers on projects under the jurisdiction of the State Building Commission that they report to the State the names and amounts of contracts entered into with minority-owned businesses on their contract with the State in order for the State to collect data on such participation.

C. For projects under the jurisdiction of the State Building Commission which utilize a procurement process for selection of a contractor which involves an evaluation of qualifications and experience as well as price, it is the intent of the Commission that such proposal evaluations will recognize the positive qualifications and experience of proposers utilizing minority, women, small and disabled businesses as well as a diverse workforce to meet service needs.

a) In support of the above it is the intent of the Commission to require proposers or bidders to submit in the qualification section of the procurement document a description of proposers existing programs and procedures encouraging diversity participation.

b) In addition, proposers are to submit the following:

- 1) Listing of proposer's current contracts involving diversity participation
- 2) Estimated dollar amount and percentage of proposed diversity participation in the current procurement
- 3) Percent of proposer's current employees by ethnicity, sex and disability


