Middle Tennessee State University, Murfreesboro, Tennessee

1) Chancellor Manning presented a request for approval of the Early Design Phase for College of Education and Behavioral Science Facility at Middle Tennessee State University in Murfreesboro, Tennessee as presented by the joint venture Earl Swenson Associates/Centric Architecture. Following the presentation, architect Marion Fowlkes discussed and demonstrated the advantages of utilizing BIM (Building Information Modeling) techniques, which reduce change orders and minimize risks. Mike Fitts stated that this technology is advantageous to owners in that it allows user agencies to review and make decisions earlier in the process, involves all of the design team earlier in the project and reduces budget risks. He said that the State would probably need to revisit the payment of fees schedule to allow more of the fee monies to be paid earlier in the project. After further discussion, the Early Design Phase was approved by the Commission.

INTERMEDIATE CARE FACILITIES / MENTAL RETARDATION HOMES - STATEWIDE

Mr. Fitts presented a request for approval of a revision in scope and funding and acknowledgment of the source of funding from \$19,520,000.00 to \$56,580,000.00 (\$37,060,000.00 increase) for **Intermediate Care Facilities / Mental Retardation Homes**, statewide, and selection of designers to enter into a joint venture with the contracted designer with regard to the additional projects in West, Middle and East Tennessee.

Speaker Naifeh mentioned that these are extraordinarily expensive homes. Commissioner Goetz answered that these people have mental disabilities and medical problems. He said that the State will own these homes, and they will be assets, although someone will be paid to operate them. Commissioner Steve Norris was recognized and spoke to the number of homes planned for each location. He said that it is an expensive capital project, but recurring savings will be substantial. Lieutenant Governor Ramsey asked Commissioner Norris what criteria they were looking for to locate the homes near Greeneville, and if the homes will be clustered or will be scattered on various tracts of land. Commissioner Norris responded that they were looking for flat land, but the homes will not necessarily be clustered. Speaker Naifeh asked if they intended to use the existing campus at Arlington to build homes. Commissioner Norris responded that they intend to build three on property across the street, but none on the campus proper. He added that long term plans are to preserve the Baker Building and move the administrative offices in there. Ultimately, they will sell the property and put the proceeds in a trust fund for people with developmental disabilities, and Greene Valley will become the main facility for DMRS. Lieutenant Governor Ramsey asked how many have been built to date. Commissioner Norris responded that three are ready to occupy in March; five have just bid; and five more have just purchased land which were approved by the SBC Executive Subcommittee.

Speaker Naifeh asked if they planned to move anyone from Arlington to Greene Valley. Commissioner Norris answered that most don't want to move that far from home and family, but one family may want to relocate their child to Middle Tennessee. Representative Shaw was recognized and asked what the law says regarding how far the new facilities can be from Arlington. Commissioner Norris responded that, beyond the 12, they can be located as far out as they want. After further discussion, the request to revise scope and funding was approved as well as the selection of the following designers to design and supervise the additional projects in West, Middle and East Tennessee:

He stated that the original estimate of \$50,000 was low, and that \$100,000 is a closer estimate of the actual cost. The Commission approved Mr. Fitts' request without objection.
