1) Chancellor Manning presented a request for approval of the Early Design Phase for Baseball Facility at East Tennessee State University in Johnson City, Tennessee, as presented by Ken Ross Architects, Inc. After Mr. Ross' presentation, Speaker Williams commented that it was a wonderful design. He said he was concerned as ETSU's football program was eliminated because of costs and he was not sure that the baseball program was profitable. He added that the students were asked to vote if they wanted to bring back football by increasing student fees. He asked if this baseball project was brought to the students for a vote. Chancellor Manning commented that the fees used to fund the baseball project were already in place from previously authorized fees. He added that football is particularly expensive, as well as being an all-male sport, and it puts a burden on other sports. He added that the reinstatement of the football program required an increase in student fees; whereas, they were using existing fees for the baseball project. Lieutenant Governor Ramsey commented that, as a graduate, he sees a movement towards bringing football back in four or five years. Chancellor Manning responded that they have nothing against football-it's just the cost involved. Speaker Williams said he could see possible opposition for the same reason. He added that he didn't want anything he said to be misconstrued because, if they were going to do baseball, they do need a facility. The request was then approved without objection.
