Treasurer Sims said he understood that the State had received two competent proposals and Flintco had the lowest cost and the highest rating for Qualification and Technical response and that the cost difference between the two was approximately \$700,000. He asked Mr. Fitts to outline for them the process and timeframe should one of the proposers be dissatisfied or want to file a protest. Mr. Fitts responded that they cannot open the records to the public until the SBC acts. But once the SBC acts, anyone who wants to file a protest has seven days to present their protest and basis for protest to the State Architect. The State Architect then reviews the protest and informs the protestor if he or she agrees or disagrees with the protest. The proposer then has a right to appeal a disapproval to the Commission. If the State Architect agrees with the protest, it is brought back to the Commission for their consideration.

Comptroller Morgan commented that the start of the process is with the State Architect. If the State Architect determines there is no basis for the protest, that entity would still have a right to bring their protest to the SBC. Treasurer Sims stated that to contest is not about just filing a letter. He said if the State Architect receives a letter in seven days, they have to be specific about their grounds for protest. He said he wanted to make sure everyone understands that there is an avenue available to protest, but only after the SBC accepts the selection of a proposer. After discussion, the request was approved as presented.


