#### DEBERRY CORRECTIONAL INSTITUTE, NASHVILLE, TENNESSEE

Commissioner White stated that the amendment would authorize temporary additional capacity to Metro while it is in the process of completing a jail facilities construction and renovation project. He said the authority would terminate within six months of substantial completion of Metro's construction/renovation project, or three years from the date of execution of the amendment, whichever occurs first. He added that the Select Oversight Committee on Correction had reviewed the amendment and approved it contingent upon the addition of language allowing the State to revoke the authority with ninety days written notice. After general discussion, the amendment was approved without objection.
