Mr. Fitts presented a request for approval of a project and acknowledgement of the source of funding for **Emergency Repairs** at the Davy Crockett Tower, Nashville, and selection of a designer to design and supervise the project. He stated that the project involved the repair of interior building systems and finish components which have been damaged from water infiltration. He said the scope of work will improve the design of the exterior building envelope to mitigate against further water damage and negative indoor air quality. Secretary of State Darnell asked if the mold problem was caused by the design or construction of the building. Mr. Fitts responded that it was difficult to say, but it could be attributed to one or the other. Secretary Darnell asked if they have asked the Attorney General about recovery of damages. Charles Garrett responded that the building is 20 years and, frankly, the State didn't take care of it.

After discussion, the Commission approved the request as presented including the selection of Gobbell-Hays Partners to design and supervise the project.
