### ***Learning Objectives***

#### **1. Theory / CJ System Overview**

- a. Understand the various criminological paradigms and identify which theories fall within each.
- b. Explain major theories under each paradigm.
- c. Identify and understand the major premise of important criminological theorists.
- d. Review the TBI's annual Crime in TN reports as a comparison to the UCR, NIBRS, and NCVS.
- e. Distinguish the police role, the judicial system function, and the correctional techniques used in dealing with offenders.
- f. Identify victimization, social controls, and the rule of law.
- g. Explore the biological, psychological and sociological research on understanding crime.
- h. Discuss the history of the public's attitudes toward the offender and the resulting changes in laws, system policies, and legal practices.
- i. Recall the laws, procedures, and policies involved in processing an offender through the criminal justice system.
- j. Discuss the criminal justice process; define crime and measures of crime.
- k. Demonstrate an understanding of the differences between the crime- control model and the due-process model as it pertains to the criminal justice system.
- l. Distinguish between the FBI's UCR/NIBRS Program and the National Crime Victimization Survey and what they can tell us about crime in the United States today.
- m. Distinguish the historical antecedents of the American legal system.
- n. Recall and evaluate the major sources of crime and victimization data.
- o. Discuss the crime trend for violent crime and property crime for the last 25 years.

## **2. Courts/Law**

- a. Discuss the pre-trial, court and adversarial processes.
- b. Explain the difference between civil law and criminal law.
- c. Discuss the history and purpose of the U.S. Supreme Court, and explain and evaluate its functions and operations.
- d. Explain the process of entering a plea in a criminal case.
- e. Discuss the role of the jury in deciding a criminal case.
- f. Describe due process and classify criminal law.
- g. Cite and describe the members of the courtroom workgroup, and what their goal is.
- h. Describe the major steps in pretrial procedures and the function of the grand jury.
- i. Distinguish the differences between the local, state, and federal court systems.
- j. Analyze how the various laws protect the individual and their rights as an American citizen.
- k. Cite and describe the steps in a criminal trial.
- l. Identify the major differences between the due process model of justice and the crime control model.
- m. Describe and discuss the Tennessee Code Annotated (crimes against property, persons, and defenses to crimes)

## **3. Law Enforcement**

- a. List and explain the different kinds of law enforcement agencies and jurisdictions.
- b. Discuss the role and function of the law enforcement.
- c. Recall the factors in society that contributed to the formation of the police.
- d. Recognize critical issues in policing: effectiveness, discretion, racial profiling, corruption, brutality, and ethics.
- e. Recognize major constitutional issues that involve policing: search and seizure and interrogation.
- f. Identify and distinguish the impact of police subcultures.
- g. Discuss and analyze how the constitution and/or court precedent empowers or limits law enforcement behavior.
- h. Describe and explain reasonable suspicion, probable cause, and elements of an arrest with/without a warrant.
- i. Discuss and explain law enforcement rules for searches and seizures, and Miranda rights.

## **4. Corrections**

- a. Develop an understanding of the historical development of prisons in America.
- b. Distinguish between prisons and jails.
- c. Discuss recent trends in corrections (supermax prisons, disproportionate

- minority confinement, gender differences and needs, gangs/security threat groups).
- d. Develop an understanding of the inmate culture based on Sykes' Society of Captives, pains of imprisonment, Clemmer's prisonization.
  - e. Discuss major Legal issues relative corrections based upon 1st, 4th, 5th, 6th, 8th, and 14th Amendments.
  - f. Discuss the goals of sentencing: retribution, deterrence, incapacitation, and rehabilitation.
  - g. Discuss the differences between probation and parole and critical issues such as: effectiveness, re-entry, probation fees and fines, risk and needs assessment.
  - h. Discuss the implications of the growth in jail and prison populations, with particular attention to the negative effects of overcrowding.

## **5. Juvenile**

- a. List and explain the basic procedural and philosophical differences
- b. between juvenile and adult criminal courts.
- c. Discuss *In re Gault* and its importance concerning juvenile constitutional rights.
- d. Explain the general procedures for arrest, intake, pretrial diversion and transfer to adult court.
- e. Examine statistics of juvenile crime and delinquency.

### **Learning Objectives**

#### **1. Equations**

- a. Apply various techniques, as appropriate, to simplify expressions and solve equations. This includes using exact symbolic (algebraic), approximation and graphical techniques.
- b. Solve quadratic equations for both real and complex roots.
- c. Solve polynomial equations of degree  $> 2$  for both real and complex roots.
- d. Use synthetic division and other relevant results to identify and simplify the equation.
- e. Solve equations involving absolute values, radical, rational, exponential or logarithmic expressions.
- f. Identify equations that can't be solved directly and use graphical or other approximations.
- g. Use the properties of logs and exponentials to simplify expressions involving logs and exponentials.

#### **2. Inequalities**

- a. Apply various techniques (algebraic and graphical) to solve inequalities involving polynomials (including degree  $> 2$ ), and absolute values, and can express answers using interval notation

#### **3. Properties of Functions**

- a. Express properties and transformations of functions graphically, and can use a graph to determine function properties
- b. On both the graph and the function can apply and identify the basic transformations:  $f(x-a)$ ,  $f(x+a)$ ,  $f(x)+a$ ,  $f(x)-a$ ,  $f(ax)$ ,  $af(x)$
- c. From the function can identify graphical functional properties and vice versa: intercepts, asymptotes (vertical, horizontal, slant), domain, range, and end behavior.

- d. From the graph can locate critical points and identify if each is a minimum, maximum or point of inflection, and locate intervals of increasing/ decreasing

#### **4. Models**

- a. Use functions to model behavior described by words and/or data
- b. Identify and make appropriate models for situations involving for example, direct and inverse proportionality, average rate of change, exponential growth and decay, logarithmic relations, and periodic behavior.
- c. Use appropriate units and function properties, like domain, as needed in function models. c) Interpret the solutions in terms of the original problem.

#### **5. Functions**

- a. Manipulate functions and identify their properties.
- b. Identify basic properties of functions (definition of function, domain, range, odd, even, asymptotic behavior)
- c. Manipulate functions as elements to get new functions via addition, subtraction, multiplication, division, and composition and can simplify the resulting expression (e.g. difference quotient)
- d. Construct and evaluate inverse functions and use domain and/or range restriction appropriately.

#### **6. Trigonometric Functions**

- a. Use trigonometric functions and identities to find specific results.
- b. Relate values on the unit circle to trig function values, and vice-versa, with numerical values at specific angles ( $0, \pi/6, \pi/4, \pi/3, \pi/2$ ) and their periodic extensions.
- c. Graph the six trigonometric functions and identify characteristics such as period, amplitude, phase shift, and asymptotes.
- d. Use trigonometric identities to evaluate numerical values, simplify expressions and solve equations. (E.g. use sum/difference identities to evaluate  $\sin(\pi/12)$ , simplify  $(\sin(x) + \cos(x))^2$ ).
- e. Apply multiple identities to simplify expressions and solve equations, including ones involving inverse functions.
- f. Solve trigonometric equations by factoring, by using identities, and by graphing.

#### **7. Triangles**

- a. Solve right triangle problems including applications.
- b. Solve right triangle problems involving angles of elevation and depression and angles using compass notation (e.g.  $30^\circ$  North) using trigonometric identities and rules.
- c. Use the Law of Cosines and Sines for all triangle types.
- d. Use vector concepts of magnitude and direction.

## 8. Circles

- a. Work with circles as a (Cartesian) conic section and in terms of its geometric and polar properties.
- b. Convert a quadratic equation into the equation of a circle or parabola using completion of squares.
- c. Identify the center and radius of a circle, and can write and use the equation of a circle from its properties.
- d. Calculate basic geometric properties like area of a sector, arc length, and the relation between the area of a sector and the inscribed triangle.
- e. Relate, through the unit circle, polar coordinates to Cartesian coordinates and vice versa

### ***Learning Objectives***

#### **1. Appropriate types of samples and sampling methods**

- a. Recognize whether a study is using simple random, systematic, stratified, or cluster sampling.
- b. Recognize the following methods of poor sampling: judgmental, convenience, and voluntary.
- c. Obtain a simple random sample using technology or tables.
- d. Distinguish between an Experiment and an Observational Study.
- e. Define and distinguish between non-sampling error and sampling error.
- f. Discuss how bias can affect the outcome of a study.

#### **2. Appropriate representation of data**

- a. Understand the term “variable” and differentiate between the data types: measurement, categorical, univariate and bivariate.
- b. Explain what is meant by “frequency distribution”.
- c. Create a frequency distribution from a list of quantitative and qualitative data.
- d. Analyze a quantitative frequency distribution table by finding the class width used, sample size, and class midpoints.
- e. Calculate the relative and cumulative frequencies from a quantitative frequency distribution table.

- f. Calculate relative frequencies for a categorical frequency distribution table.
- g. Construct a histogram from frequency distribution table.
- h. Construct and/or interpret the following statistical graphs: Histogram, Scatterplot, Pie Chart, Bar Graph, Pareto Chart, Time series, Stem and Leaf plot, Dot plot, and Box plot.
- i. Interpret the shape of the distribution from a histogram (i.e. symmetrical, skewed, uniform, and bimodal).
- j. Identify why a graph might be misleading.
- k. Compare strengths and weaknesses of each type of statistical graph.
- l. Compare the distribution of two or more data sets that have used various graphical tools.

### **3. Measure of Center and Variation**

- a. Understand the measurements of center such as mean, median, and mode.
- b. Understand the measurements of spread such as range, variance, and standard deviation.
- c. Understand the effects of outliers on the measurement of center and measurement of spread.
- d. Calculate the mean and median using a set of data.
- e. Recognize the mode from a set of data.
- f. Calculate mean of a frequency distribution such as GPA and weighted grade.
- g. Recognize the mode from a frequency distribution.
- h. Calculate range from a data set.
- i. Calculate and interpret the standard deviation from a set of data with or without technology.

### **4. Probability and Statistics**

- a. Explain the difference between empirical, theoretical, and subjective probability.
- b. Understand the concept of randomness (i.e. flipping a coin, rolling a die, drawing a card from a standard 52 card deck).
- c. List the elements of events and the sample space from an experiment.
- d. Find basic probabilities using the definition of probability.
- e. Use tree diagrams, Venn diagrams, and/or lists to solve probability problems where appropriate.
- f. Explain the Law of Large Numbers.
- g. Calculate and interpret probabilities using the complement rule, addition rule, and multiplication rule.
- h. Calculate and interpret conditional probabilities.
- i. Identify events as mutually exclusive or not mutually exclusive.
- j. Identify events as independent or dependent.
- k. Discuss the differences in the ways probabilities are calculated when events are mutually exclusive versus not mutually exclusive.
- l. Discuss the differences in the ways probabilities are calculated when events are independent versus dependent.



- m. Explain the difference between mutually exclusive events and independent events.

## 5. Discrete Probability Distribution Objectives

- a. Identify the random variable in a probability experiment.
- b. Distinguish between discrete random variables and continuous random variables.
- c. Create a simple probability distribution for the values of a discrete random variable.
- d. Create a probability table for a discrete random variable.
- e. Use a probability function to determine probabilities associated with a discrete random variable.
- f. Create a probability histogram based on a probability table.
- g. Calculate and interpret the mean/expected value, variance, and standard deviation of a discrete random variable.
- h. Define and recognize discrete binomial probability distribution.
- i. Understand proper notation and calculate binomial probabilities.
- j. Calculate the Mean/Expected Value, Variance, and Standard Deviation for Discrete Binomial Probability Distributions.
- k. Use both range rule of thumb and probabilities to determine unusual values for the random variables.

## 6. Normal Probability Distribution

- a. Explain the characteristics of why the normal distribution is so important.
- b. Use area under a probability density curve to find probabilities for two different continuous random variables (the uniform distribution and the normal distribution).
- c. Know what “standardizing” data means so that the z-table can be used if the data are normally distributed.
- d. Calculate and interpret a z-score.
- e. Given a histogram from raw data determine if the distribution is a normal model.
- f. Understand the Empirical Rule and the general properties of the normal distribution. (i.e., 100% is the total area under the curve, exactly 50% is to the left and right of the mean, and it is perfectly symmetric about the mean).
- g. Use the Z-table or TI-83/84 calculator to find area under the curve for any normal distribution model (left, right, between).
- h. Use the Z-table or TI-83/84 calculator to find percentiles, quartiles, or any other numerical value of X for a specified area under the curve for any normal distribution model.

## 7. Sampling Distributions and the Central Limit Theorem

- a. Describe the characteristics of the distribution of the sample mean: normal population.
- b. Describe the characteristics of the distribution of the sample mean: non-normal population.

- c. Describe the characteristics of the distribution of the sample proportion.
- d. Understand the impact of sample size on sampling variability.
- e. Understand the Central Limit Theorem and conditions to apply.
- f. Apply the Central Limit Theorem to normal and non-normal populations and compute probabilities of a sample mean.

## 8. Estimates and Sample Sizes (Confidence Intervals)

- a. Estimating a Population Proportion  $p$
- b. Calculate sample proportion.
- c. Understand that the sample proportion is the best point estimate of the population proportion.
- d. Find critical values  $z_{\alpha/2}$  for a given value of  $\alpha$ .
- e. Calculate the margin of error using sample statistics.
- f. Use a sample proportion to construct a confidence interval to estimate the true value of a population proportion.
- g. Interpret a confidence interval in context.
- h. Understand the effect of changing the confidence level and/or the sample size on the width of the confidence interval.
- i. Verify the conditions are met for estimating a population proportion.
- j. Write a confidence interval in 3 different forms (point estimate plus/or minus margin error, interval notation, set notation).
- k. Find the best point estimate and the margin of error when given a confidence interval.
- l. Know how to find the sample size necessary to estimate a population proportion.

## 9. Estimating a Population Mean: $\sigma$ Known and Not Known

- a. Understand that the sample mean  $\bar{x}$  is the best point estimate of the population mean  $\mu$ .
- b. Know the difference between the sample standard deviation ( $s$ ) and standard error of the mean  $\left(\frac{s}{\sqrt{n}}\right)$
- c. Find critical values or either  $z_{\alpha/2}$  or  $t_{\alpha/2}$  for a given value of  $\alpha$  and degrees of freedom depending on if sigma is known.
- d. Calculate the margin of error using sample statistics.
- e. Use sample data to construct a confidence interval for estimating the value of a population mean, and interpret such confidence intervals.
- f. Write a confidence interval in 3 different forms (point estimate plus/or minus margin error, interval notation, set notation).

- g. Find the best point estimate and the margin of error when given a confidence interval.

## 10. Hypothesis testing Objectives

- a. Identify the claim in a problem.
- b. Determine the appropriate null and alternative hypothesis when presented with a problem.
- c. Determine if a test is left - , right - or two-tailed.
- d. Understand and list the assumptions for a z-test and t-test.
- e. Calculate critical values for tests involving a single proportion, a single mean, and difference between two means.
- f. Find p-values for z test statistics using a z-table or technology.
- g. Find p-values for t test statistics using t-table or technology.
- h. Determine whether or not to reject or fail to reject the null hypothesis using both the traditional and p-value methods.
- i. Conduct hypothesis testing for single proportion, single mean, and the difference between two means.
- j. Draw conclusions and make inferences about claims based on hypothesis testing.
- k. Explain Type I and Type II errors.
- l. Distinguish between independent and dependent sampling.
- m. Test hypotheses regarding the difference of two independent means (assume the variance are not pooled).

## 11. Linear Regression and Correlation

- a. Understand the assumptions of linear regression.
- b. Demonstrate the ability to identify the independent/explanatory variable ( $x$ ) and the dependent/response variable ( $y$ ).
- c. Demonstrate the ability to draw a scatter diagram, identify the type of relationship that exist between two variables and find the correlation coefficient either using a technology or the traditional method (formula).
- d. Find the line of best fit and interpret the coefficient of determination (as well as effects of confounding variables).
- e. Determine if line of best fit is statistically significant.
- f. For a given value of  $x$ , find the appropriate estimated value of  $y$ .
- g. Understand the difference between practical and statistical significance.
- h. Understand that correlation does not apply causation.
- i. Understand the difference of interpolation and extrapolation.
- j. Understand the possible problems of extrapolation.
- k. Calculate a residual using the line of best fit.
- l. Perform residual analysis to check assumptions of regression.
