

**Career and Technical Education (CTE) Standards**

**The Background:**

T.C.A. § 49-1-302(a)(8) authorizes the State Board of Education to “set policies governing all academic standards and courses of study in the public schools.” Additionally, State Board Rule 0520-01-03-.05(1) calls for the State Board to adopt standards for each subject area, grades K-12. The approved standards are to be the basis for planning instructional programs in each local school system.

This item includes new and revised course standards for the following CTE career clusters:

- Advanced Manufacturing;
- Agriculture, Food, and Natural Resources;
- Business Management and Administration;
- Information Technology;
- Law, Public Safety, Corrections, and Security.

These new and revised standards have been reviewed by industry, secondary, and postsecondary partners. Additional feedback was solicited between first and final reading. Pursuant to T.C.A. § 49-1-309, the State Board submitted the proposed changes to the education committees of the House and Senate prior to final reading. These changes will go into effect for the 2021-22 school year.
