Mr. Mollenhour seconded the motion. All members voted to approve the motion.

- II. **Action Items (First Reading)**
 - A. **Non-Public Schools Administrative Rule 0520-07-01** (05:42-13:48)
 First reading of the item to remove outdated language, provide greater clarity regarding the maintenance of student records and transfers of students, and to specify reporting and monitoring requirements applicable to non-public schools. Ms. Angie Sanders, General Counsel for the State Board of Education, presented the item. Mr. Eby requested the addition of definitions to the rule between first and final reading. Mr. Eby made the motion and Mr. Cobbins seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
 - B. **Non-Public Schools Approval Process Rule 0520-07-02** (13:48-16:19)
 First reading of the item to remove outdated language, ensure consistency with current state and federal laws and rules, and to provide greater clarity regarding the specific requirements applicable to each category of non-public schools. The item was presented by Ms. Angie Sanders. Mr. Cobbins made the motion and Mr. Holt seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
 - C. **Special Courses Policy 3.201** (16:20-18:50)
 First reading of the item to specify the process for a charter school to request approval of a special course. Ms. Angie Sanders presented the item. Mr. Eby made the motion and Mr. Morrow seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
 - D. **Uniform Grading System Permanent Rule 0520-01-03-.02** (18:51-29:28)
 First reading of the item to align this rule with Public Chapter 1080 of the 2022 legislative session. Ms. Catherine Johnson, Deputy Director of Academic Policy for the State Board of Education, presented the item. Mr. Wells made the motion and Mr. Cobbins seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.

- E. Educator Licensure Rule 0520-02-03-.02 through -.05 and -.10 through -.15** (29:29-31:32)
 First reading of the item to make various revisions to the Educator Licensure Rule in response to recent statutory changes, including Public Chapter 692, Public Chapter 932, and Public Chapter 1093 of the 2022 legislative session. Revisions include creating a Limited License pathway, adding flexibilities for issuance of permits and endorsement exemptions, and expanding the type of qualifying experience for individuals applying for an instructional leader license through an out-of-state pathway. Mr. Jack Powers, Director of Policy at the Department of Education, presented the item. Mr. Morrow made the motion and Mr. Holt seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- F. Graduation Requirements Rule 0520-01-03-.06** (31:33-38:05)
 First reading of the item to add requirements for an Industry 4.0 diploma distinction pursuant to Public Chapter 946 of the 2022 legislative session. Revisions also include adding computer science as a graduation requirement starting with 9th grade students in the 2024-25 school year pursuant to Public Chapter 979 of 2022. Ms. Deborah Knoll, Assistant Commissioner of CTE for the Department of Education, presented the item. Mr. Eby made the motion and Mr. Wells seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- G. Evaluations - General Requirements for Evaluations Rule** (38:06-41:00)
 First reading of the item to align the Educator Evaluation Rule with recent statutory changes, including Public Chapter 991 and Public Chapter 1096 of the 2022 legislative session. Ms. Martha Moore, Senior Director of Educator Effectiveness for the Department of Education, presented the item. Mr. Cobbins made the motion and Mr. Holt seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- H. Individualized Education Accounts (IEA) Rule 0520-01-11-.02, -.04, -.06, and -.08** (41:01-44:39)
 First reading of the item to add “specific learning disability” as an eligible disability category for the IEA program pursuant to Public Chapter 1019 of the 2022 legislative session. Ms. Robin Yeh, Policy Analyst for the Tennessee Department of Education, presented the item. Mr. Cobbins requested a report on the IEA participation rate before final reading. Mr. Darnell made the motion and Mr. Cobbins seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- I. Special Education Programs and Services Rule 0520-01-09-.10 and .11 (item pulled from agenda)**
 First reading of the item to revise the funding requirements in the Special Education Programs and Services rule to remove references to the Basic Education Program (BEP) following passage of the Tennessee Investment in Student Achievement (TISA) Act.

At the Chairman’s request and without objection, this item was removed from the agenda and will be presented at a later meeting.

- J. Course Access Program Rule 0520-01-14-.02 through -.06** (44:40-46:19)
 First reading of the item to align the Course Access Program Rule with recent statutory changes from Public Chapter 929 of the 2022 legislative session. Mr. Jack Powers presented the item. Mr. Eby made the motion and Mr. Morrow seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- K. Career and Technical Education (CTE) Course Standards** (46:20-53:54)
 First reading of the item to revise course standards for several CTE career clusters. Ms. Sarah Williams, Senior Director of Career and Technical Education for the Department of Education, presented the item. Chairman Hartgrove requested further definition and examples of professionalism be added between first and final reading. Mr. Morrow made the motion and Mr. Darnell seconded the motion to accept the item on first reading. All members voted to approve the motion by voice vote.
- L. Dyslexia Individualized Learning Plans Rule 0520-01-22 (item pulled from agenda)**
 First reading of the item to create a new rule to outline requirements for LEAs to develop dyslexia individualized learning plan for students identified with characteristics of dyslexia.
- At the Chairman's request and without objection, this item was removed from the agenda and will be presented at a later meeting.
- M. English as a Second Language (ESL) Programs Rule 0520-01-19 (item pulled from agenda)**
 First reading of the item to revise the English as a Second Language rule to align with the proposed rules for the Tennessee Investment in Student Achievement (TISA) Act.
- At the Chairman's request and without objection, this item was removed from the agenda and will be presented at a later meeting.
- N. Interscholastic Athletics Rule 0520-01-23** (53:55-1:01:08)
 First reading of the item to create an Interscholastic Athletics rule pursuant to Public Chapter 909 of the 2022 legislative session. Ms. Shaundraya Hersey, Staff Attorney for the Department of Education, presented the item. Mr. Holt and Mr. Morrow requested that additional clarity be provided between first and final reading on the Commissioner's authority and the process to determine the amount of funds withheld. Mr. Wells made the motion and Mr. Mollenhour seconded the motion to accept the item on first reading. Mr. Cobbins opposed the motion while all other members voted to approve the motion by voice vote.
- O. Tennessee Academic Standards for Science** (1:01:09-1:07:14)
 First reading of the item to approve revisions to the K-12 Science Standards, as recommended by the Science Standards Recommendation Committee. Ms. Catherine Johnson presented the item. Mr. Eby made the motion and Mr. Holt seconded the motion to accept the item on first reading. All members voted to approve the motion.

 Final reading of the item to create a new category of offenses that are subject to disciplinary action to include misdemeanor convictions where the victim is a minor and to make other technical corrections. There have been changes to this item since first reading. Mr. Todd Madison, Senior Staff Attorney for the State Board of Education, presented the item. This item required a roll-call vote.

C. Repeal English as a Second Language (ESL) Program Policy 3.207 (1:12:56-1:14:16)
 Final reading of the item to repeal policy 3.207 due to duplicative content with ESL Rule 0520-01-19. There have been no changes to this item since first reading. Ms. Catherine Johnson presented the item. Mr. Darnell made the motion and Mr. Holt seconded the motion to approve the item on final reading. All members voted to approve the motion by voice vote.

D. Statewide Dual Credit (SDC) Course Approval – Sociology Course Standards (1:14:17-1:18:46)
 Final reading of the item to remove approval of SDE Sociology course due to conflicts with law. There have been no changes to this item since first reading. Ms. Catherine Johnson presented the item. Mr. Mollenhour made the motion and Mr. Eby seconded the motion

to approve the item on final reading. All members voted to approve the motion by voice vote.
