## LICENSURE COHERENCE PROJECT

Partnership began last spring/summer with SBE, TDOE, and National Association of State Boards of Education (NASBE).

#### Goals:

- ✓ Ground conversation in a clear picture of the current licensure structure in Tennessee.
- ✓ Convene stakeholders to discuss strengths, weaknesses, opportunities in current system.
- ✓ Develop proposals to support coherence and a clear vision for the purpose of professional educator licensure.
- ✓ Take up emerging issues, including: edTPA, Occupational Licensure, Special Education, communications, and endorsement structure.

## LICENSURE REVIEW COMMITTEE

- In December and January, SBE staff began accepting applications for the new Educator Licensure Review Committee.
- Just under 100 applications received.
- Applicants included current educators, district administrators, educator preparation provider leadership and staff, statewide advocacy groups, and members of the Tennessee General Assembly.
- SBE and TDOE staff reviewed applications and selected a group of 24 individuals that represent all areas of the state, and ensure a wide variety of school, district, and other stakeholder perspectives.
- The Committee will meet 1-2 times per year.
