2023-24 Virtual Education Annual Report

Tennessee Department of Education | Division of Choice | February 2025

Executive Summary

Annually, the Tennessee Department of Education (department) releases a report to highlight the state of virtual education in Tennessee. This year's report provides information relative to the operation and viability of public virtual schools and virtual education programs for the 2023-24 school year. In compliance with state statute¹, the report provides information relative to student enrollment, academic performance, and funding for virtual education and includes data for public virtual schools and their establishing local education agencies (LEAs). Highlights in Public Virtual Education

- The number of public virtual schools operating in Tennessee remained steady with 58 schools during the 2023-24 school year, compared to 59 schools in 2022-23.
- Enrollment in Tennessee public virtual schools remained steady with 12,630 students during the 2023-24 school year compared to 12,653 students in 2022-23.
- Approximately a third of Tennessee's non-virtual public high schools offered online or virtual courses in addition to traditional in-person courses during the 2023-24 school year.
- Many virtual schools provide a temporary alternative to traditional schooling for students who have unique needs. These flexibilities lead to increased student mobility, and studies have shown that increased mobility leads to unfavorable academic outcomes.
- Approximately 30% of students enrolled in a virtual school did not remain enrolled in the school for the entirety of the school year; this is a significantly higher mobility rate compared to the mobility rate of students attending a non-virtual school (14%).
- The number of virtual schools that earned a school-wide TVAAS composite score of 3 or greater (21%) was significantly lower than the number of non-virtual schools that met the same measure (66%).
- The department has implemented a virtual school monitoring framework that analyzes the operational, academic, and fiscal viability of a virtual school.

Virtual Education Landscape in Tennessee

Legislative History of Virtual Education in Tennessee

The Tennessee General Assembly passed Chapter 1096 of the Public Acts of 2008², which provides school districts and students with a broader range of educational opportunities through effective use of technology outside of a traditional classroom. Through this Act, local education agencies (LEAs) were granted the authority to utilize state education funds, seek out grant funds, and accept donations to implement virtual education programs. Although this Act promoted virtual education, LEAs maintained discretionary authority whether to offer virtual education for its students.

In 2011, the General Assembly enacted the Virtual Public Schools Act³ to expand upon previously enacted virtual education program legislation. This Act gave LEAs the authority to establish virtual public schools to offer students additional educational opportunities. Furthermore, virtual schools established under this Act are public schools and must be allotted the same resources afforded to other public schools in Tennessee. In addition, the Act required the Tennessee State Board of Education (SBE) to promulgate rules and regulations related to the operation and establishment of virtual schools and virtual education programs⁴.

Divisions of Virtual Education

SBE rule⁵ divides virtual education into two separate categories: public virtual schools and virtual education programs. This differentiation provides both LEAs and public schools with the flexibility to offer virtual education to students as needed. LEAs may establish and operate a public virtual school to deliver instruction to students primarily via the internet in a virtual or remote setting⁶. Public virtual schools are public schools and are held to the same rigorous standards as other public schools in Tennessee. Unlike traditional public schools, the commissioner has the authority to reinstate an enrollment cap for a public virtual school or direct the LEA to close the school if it is identified as a Priority school or demonstrates student

achievement growth at a level of “significantly below expectations” for any three (3) consecutive years of the school's operation⁷.

Additionally, LEAs have discretion to allow students enrolled within a virtual school to attend a portion of their classes in-person within a brick-and-mortar location if needed. Students may choose to remain enrolled in a public non-virtual school and still participate in virtual education through a virtual education program. A virtual education program is a course or series of courses accessed by students through technology. LEAs and public charter schools may use virtual education programs to provide students with a broader range of educational opportunities outside of a traditional school setting. Unlike public virtual schools, virtual education programs are not separate schools and must operate through an already established public school. During the 2023-24 school year, a third of Tennessee public high schools offered online or distance learning courses through a virtual education program in addition to traditional in-person courses. In total, approximately 54% of LEAs provided students with access to a virtual education program through a non-virtual school to expand curricular offerings during the 2023-24 school year.

Establishment of Virtual Schools

The department has created a thorough application process by which LEAs must apply to open a virtual school. During the application process, LEAs must submit evidence showing that the school's academic, operational, and fiscal practices will align to all applicable statutes and rules that govern public schools and public virtual schools in Tennessee. LEAs may utilize both state and local funds to implement and operate public virtual schools and virtual education programs.

Most LEAs in Tennessee offer access to virtual courses as a flexible choice for students and families. LEAs may staff and manage public virtual schools with personnel employed by the LEA or may contract management services with another entity. However, all teachers, regardless of employer, must have the necessary endorsement(s) on their Tennessee educator license to teach each course. Regardless of the management entity, all public virtual schools and virtual education programs must comply with laws, rules, and regulations applicable to public schools in Tennessee. Furthermore, public virtual schools are required to comply with all federal laws addressing special populations, including the Individuals with Disabilities Education Act (IDEA), and must provide all services required by a student's Individualized Education Program (IEP),

Section 504 Plan, or Individual Learning Plan (ILP). Therefore, students with unique learning needs, including those with disabilities and limited English proficiency, may enroll and participate in a public virtual school or virtual education program. Access to virtual education provides Tennessee students with a personalized pathway to learning that is not constrained by geography or a traditional bell schedule. Both virtual schools and non-virtual schools can provide students with access to a variety of instructional modalities including:

- **Synchronous Virtual Courses:** courses that are fully online/virtual in which a student can progress independently through coursework and requires students to attend regularly scheduled (daily/every other day) virtual classes with a teacher.
- **Asynchronous Virtual Courses:** courses that are fully online/virtual in which a student can progress independently through coursework and does not require students to attend regularly scheduled (daily/every other day) virtual classes with a teacher.
- **Bisynchronous Virtual Courses:** courses that are fully online/virtual and utilize a mixture of asynchronous and synchronous instruction.
- **Hybrid Virtual Courses (allowable in public virtual schools only):** courses that offer primarily virtual instruction (asynchronous, synchronous, or bisynchronous) and requires students to periodically attend class in-person within a brick-and-mortar location.


Public Virtual School Operation and Enrollment

The number of public virtual schools operating in Tennessee has significantly increased since 2011 and has remained consistent for the past two years as seen in figure 1. During the 2023-24 school year, 58 public virtual schools operated across 51 LEAs. Student participation in virtual education, specifically virtual schooling, has seen an upward trend since 2011 and has remained stable in the last few years as seen in figure 2. During the 2021-22 school year, student enrollment in virtual schools significantly increased due to parental choice during the COVID-19 pandemic. This sudden increase was followed by a significant decrease in student enrollment during the 2022-23 school year. However, post-pandemic public virtual school enrollment remains higher than pre-pandemic enrollment.

In the 2023-24 school year, 19 public virtual schools offered a statewide enrollment option for any Tennessee student that met the school's enrollment criteria. LEAs that allow out-of-district or state-wide enrollment may charge tuition to families for the portion of funding that the LEA receives from local city or county taxes. LEAs that operate a virtual school are not required to offer out-of-district or state-wide enrollment options. As shown in Table 1, 47% of public virtual schools operating in the 2023-24 school year did not offer out-of-district or statewide enrollment opportunities.



Student Enrollment

Student population characteristics within public virtual schools and non-virtual schools are similar⁸. Compared to non-virtual schools, public virtual schools held a smaller proportion of English Learners (EL) and Hispanic students during the 2023-24 school year. This data trend is not unique to Tennessee; a national study found that across the U.S., fewer EL students participate in virtual schooling as compared to other student populations⁹.

Student Mobility


Public virtual schools in Tennessee have significantly higher mobility rates compared to non-virtual schools. Approximately 30% of students who enrolled in a virtual school did not remain enrolled in the school for the entirety of the school year as compared to 14% of students in non-virtual schools. LEAs often use virtual schooling to meet the needs of students and families that need an alternative to a traditional school setting. Virtual education provides flexibility for LEAs to meet the needs of its students; however, this type of utilization lends itself to increased

student mobility. This underscores a unique challenge that virtual schools face when compared to non-virtual schools. To address this challenge, virtual school leaders plan for increased mobility and student transience by offering flexible scheduling and varying types of instructional modalities to fit student and family needs and support the transition back to non-virtual schooling. Virtual school leaders have indicated that a consistently changing student body impacts their ability to effectively monitor academic progress and increase student achievement. Studies have shown that students who experience school mobility face significant academic challenges, including lower test scores and increased risks of grade retention and dropout¹⁰. Research also indicates that school-wide mobility negatively impacts both mobile and non-mobile students, contributing to lower overall school performance¹¹. For purposes of this report, student mobility rate is the percentage of a student body entering, reentering, and/or withdrawing on or after October 1st of a school year. Figure 5 presents the overall mobility rates for both students in virtual schools and non-virtual schools during the 2023-24 school year¹².

Accountability

Public virtual schools in Tennessee operate under the same legal and regulatory framework as all other public schools in the state. [T.C.A. § 49-16-213](#) frames additional accountability measures that focus on student achievement growth, as represented by the Tennessee Value-Added Assessment System (TVAAS). TVAAS composites are one-year scores reported on a 1-5

scale¹³. If a virtual school demonstrates overall student achievement growth (school-wide TVAAS composite) at a level 1 indicating “significantly below expectations” for any three consecutive years of the school’s operation, the commissioner of education has the authority to enforce an enrollment cap or direct the establishing LEA to close the public virtual school. The Tennessee Department of Education shares accountability data for public schools, including public virtual schools, in the annual Tennessee State [Report Card](#) and assigns [School Letter Grades](#) to all eligible public schools including public virtual schools. These data sources are a vital tool for parents and families seeking comprehensive information about school performance.

Academic Outcomes





Figure 7. Percentage of Schools by School-Wide TVAAS Composite Level, 2023-24

During the 2023-24 school year, students within non-virtual schools demonstrated a higher rate of academic achievement compared to students within virtual schools as illustrated in figure 6. Moreover, 21% of public virtual schools achieved a school-wide TVAAS composite score of 3 or greater. This percentage is considerably lower than the 66% of non-virtual schools that achieved the same benchmark as illustrated in figure 7.

Figure 8 illustrates that 45% of virtual schools secured a school-wide TVAAS composite score equivalent to or exceeding their establishing LEA while 53% of non-virtual schools met this same measure.

Figure 6. Percentage of Students On-track or Mastered by School Type, 2023-24

Figure 8. School-wide TVAAS Composites Compared to System-wide TVAAS Composites, 2023-24





Figure 9. Percentage of Schools Earning TVAAS Composite Level Equivalent to or Higher than LEA, Over Time



School Letter Grades

Pursuant to Tennessee law¹⁴, the department developed a [school letter grade rating system](#) to provide parents and families with information that shows how public schools in Tennessee are performing. The department calculates letter grades on a scale from A to F. These grades are based on four separate indicators: student achievement, student academic growth, growth of the highest need students, and college and career readiness measure for high schools. A higher percentage of non-virtual schools (73%) earned a letter grade ranging from A to C than virtual schools (20%). Appendix F provides the letter grade earned by each eligible public virtual school.

School Recognitions

Each year, in accordance with Tennessee's accountability system and federal and state law, the Tennessee Department of Education recognizes schools for their success, as well as those needing additional support. Reward Schools, as defined by the department's [2023-24 Accountability Protocol](#), are schools that earn an overall school score of 3.1 or higher per federal accountability calculation and are not identified as Comprehensive Support and Improvement Schools (CSI), Targeted Support and Improvement Schools (TSI), or Additional Targeted Support and Improvement Schools (ATSI). Schools serving K-8 students are evaluated on four indicators, including achievement on the Tennessee Comprehensive Assessment Program (TCAP) assessments, TCAP assessment growth over time, rates at which students are Chronically Out of School, and performance on the English Language Proficiency Assessment (ELPA). In addition to these four indicators, high schools are also evaluated on Graduation Rate

and *Ready Graduate Rate*, or the rate at which students graduate while also having achieved milestones associated with college and career readiness. Schools are recognized as a Reward school when they demonstrate high levels of performance and/or improvement in performance by meeting their annual measurable objectives across performance indicators and student groups. Table 2 and Table 3 below highlight school designations for the 2023-24 school year.

Comprehensive and Targeted Support Designations

Tennessee designates a school as a Comprehensive Support and Improvement (CSI) school when the school earns performance scores in the bottom five percent of all Tennessee public schools or exhibits a graduation rate of less than 67%. A school is identified as a Targeted Support School (TSI) when any student group within the school earns performance scores in the bottom five percent of the overall performance of Tennessee students. Furthermore, a school is identified as an Additional Targeted Support and Improvement (ATSI) school when the performance scores of any student group within the school aligns with CSI criteria. Schools identified as CSI, TSI, and ATSI are eligible for additional funding and receive support from the department to develop evidence-based school improvement plans. These plans are based on items identified within the individual school's needs assessment and root cause analysis.

Funding

As delineated in [T.C.A. § 49-16-204](#), Tennessee law assures that public virtual schools are provided the same resources as other public schools operating in Tennessee. Local Education Agencies have the authority to allocate funds from both state and local sources for the establishment and operation of their virtual schools and virtual education programs. [Appendix](#)

[G](#) provides an overview of funding for all operational virtual schools during the 2023-24 school year. Both state and local funding shares are set based on each county's fiscal capacity, or ability to raise local revenue; counties with higher fiscal capacities receive less state funding as a percentage of their total budget and must contribute more local matching dollars than counties with less ability to raise local revenue.

Actions Taken to Strengthen Virtual Education in Tennessee

Virtual education serves as a flexible educational pathway for Tennessee students. To ensure that all students receive quality educational services, the department has set forth a focused effort to strengthen virtual education across the state. Supports provided by the department cover a broad spectrum, from helping LEAs craft operational guidelines to fostering partnerships between virtual and non-virtual schools. The list below outlines strides that the department is taking to strengthen virtual education:

1. The department has established a virtual school monitoring framework for LEAs to evaluate the academic, operational, and fiscal capacity of their public virtual schools. Annually, these monitoring data are used to refine and enhance the monitoring framework for the next monitoring cycle.
2. The department provides technical support to LEAs seeking to open a public virtual school. These supports help LEAs develop policies and procedures to ensure that the operation of their virtual schools align with applicable rules, regulations, and best practices as outlined by the department.
3. The department fosters collaboration between LEAs that seek to open a virtual school and LEAs that have previously established a virtual school. These partnerships provide a support network to LEAs as they plan and open virtual schools and programs.
4. The department uses virtual school monitoring data and accountability data to develop guidance and establish best practices relative to challenges and trends identified by LEAs that operate virtual schools.

Conclusion

Tennessee law allows LEAs to utilize high quality virtual education programming as a choice for families in Tennessee. The significant growth in the number of students who participate in virtual education highlights the increasing demand from Tennessee families for these flexible and diverse educational opportunities. Despite the increasing demand of virtual education, high student mobility continues to impact public virtual schools' academic outcomes. The

department has established a dedicated school choice division to address challenges that are unique to public virtual schools and virtual education programs. This division helps LEAs establish practices to ensure their students receive high-quality educational services regardless of learning modality and provides strategic supports to enhance the quality of virtual education across the state.

Level 3	Average Effectiveness: Evidence that the school's students made progress similar to the Growth Standard (the school's index is between -1 and 1).
Level 4	Above Average Effectiveness: Moderate evidence that the school's students made more progress than the Growth Standard (the school's index is between 1 and 2).
Level 5	Most Effective: Significant evidence that the school's students made more progress than the Growth Standard (the school's index is 2 or greater).
