# Where We Are: Our Current Master Plan

#### The State Board's Master Plan

- The State Board's mission is to ensure rules, policies, and systems are in place so that all students are prepared for success after graduation.
- T.C.A. § 49-1-302 charges the State Board with:
  - Developing and maintaining a master plan for public education
  - Providing recommendations regarding the use of public funds for education
- Master Plan supports stakeholders to examine if rules and policies are positioning school districts to prepare Tennessee students for workforce, postsecondary success, and engaged citizenship



#### The State Board's Master Plan

- The Master Plan outlines the Board's strategic focus areas over a three-year period.
- Each strategic focus area has goals to strive for and action steps the Board can and will take to work towards each goal.
- The Board approves its annual Master Plan progress report each winter to update progress on goals and action steps.
- Board meeting items and more are aligned to a strategic focus area within the Master Plan.



### Strategic Focus on Literacy




All students are on grade level in English language arts (ELA) as measured by the Tennessee Comprehensive Assessment Program (TCAP) results.

- The percentage of all third-grade students on grade level in ELA will increase by 4 points annually; economically disadvantaged students and students with disabilities will increase by 5 points; and English learners by 6 points.
- The percentage of all eighth-grade students on grade level in ELA will increase by 5 points annually; economically disadvantaged students, students with disabilities and English learners will increase by 6 points.




### Almost all student groups improved on the 3<sup>rd</sup> grade ELA TCAP over three years, but growth was slower than Master Plan goals.





## Almost all student groups improved on the 8<sup>th</sup> grade ELA TCAP over three years, but increase was slower than Master Plan goals.





## Strategic Focus on Postsecondary & Career




All students are prepared for success in high school, postsecondary, and career.

- ▶ The percentage of all students demonstrating readiness for postsecondary and careers after high school will increase by 4 points annually; economically disadvantaged will increase by 5 points and students with disabilities and English learners will increase by 6 points.
- The percentage of students enrolling in a postsecondary institution following graduation will increase by 3 points annually.




## High school graduates' postsecondary readiness improved across all student groups over three years, and we met two of our four student group goals in 2024.





## Student enrollment in postsecondary education continues to recover post-pandemic, and we were close to achieving our goal.





## Strategic Focus on Teachers & Leaders




All schools are staffed with qualified and effective educators.

- The percentage of newly licensed teachers who remain teaching in Tennessee public schools for at least three years will increase by 0.5 points annually.
- 65% of the educators teaching on a permit will obtain a full and valid practitioner or professional license within three years.




## The percentage of newly licensed teachers who remain in Tennessee public schools for at least three years increased last year.





## Less than half of educators teaching on a permit are obtaining a full and valid license within three years.



### Strategic Focus: Literacy



All students are on grade level in English language arts (ELA) as measured by the Tennessee Comprehensive Assessment Program (TCAP) results.

- The percentage of all third-grade students on grade level in ELA will increase by 4 points annually; economically disadvantaged students and students with disabilities will increase by 5 points; and English learners by 6 points.
- The percentage of all eighth-grade students on grade level in ELA will increase by 5 points annually; economically disadvantaged students, students with disabilities and English learners will increase by 6 points.

Setting goals by grade band, as appropriate (K-5, 6-8, 9-12)

Ensuring language is student-focused

## Strategic Focus: Postsecondary & Career



All students are prepared for success in high school, postsecondary, and career.

- The percentage of all students demonstrating readiness for postsecondary and careers after high school will increase by 4 points annually; economically disadvantaged will increase by 5 points and students with disabilities and English learners will increase by 6 points.

Adding a goal or action(s) focused on the development of individualized plans

Ensuring we have the right improvement metrics/measures

Balancing opportunities with expectations that might not suit all students



### Strategic Focus: Teachers & Leaders



All schools are staffed with qualified and effective educators.

- The percentage of newly licensed teachers who remain teaching in Tennessee public schools for at least three years will increase by 0.5 points annually.
- 65% of the educators teaching on a permit will obtain a full and valid practitioner or professional license within three years.



#### Feedback & Discussion

#### **Considerations from Staff**

Adding an action that requires the review of best practices and/or metrics from the Report Card, educator survey

Adding an action that revisits the effectiveness of teacher evaluations and differentiated compensation policies for districts

Adding an action that requires an investigation into the factors that impact why a permit holder would not move to a permanent license

#### **Considerations from Members**

Increasing the goal and/or establishing annual increments rather a singular three-year goal

Adding a goal on retaining effective educators and leaders

Ensuring we have the right improvement metrics/measures
