I. Purpose

T.C.A § 49-13-111(o) requires the governing body of a charter school to conduct an annual board training. The training course(s) shall be approved by the State Board.

State Board Rule 0520-14-01-.07 contains the information required by the State Board for use in reviewing courses for approval. Additionally, the rule contains the required number of annual training hours for new and experienced governing body members and the timeline for completing the annual training. Governing body members may establish compliance with the required training hours through one (1) course meeting the minimum credit hours or multiple courses meeting the minimum training hours. Completed training courses are valid for only one (1) year. The approved course providers shall inform the respective charter school authorizers of each governing body member's completion of the training requirements. Charter school authorizers shall be responsible for monitoring compliance for their authorized charter schools.

This policy lists the training courses that are approved by the State Board and available for use by charter school governing bodies to meet the training requirements under T.C.A. § 49-13-111(o) and State Board rule 0520-14-01-.07.

II. Approved Charter School Governing Body Training Courses

The following training courses are approved by the State Board for new and experienced governing body members. These courses meet the training course requirements of State Board Rule 0520-14-01-.07 and count toward the required training hours for governing body members. Approved courses are valid for three (3) years, unless otherwise noted.

New governing body members shall complete a minimum of two (2) credit hours of training courses from Table 1 and may choose from Table 1 or Table 2 to meet the additional four (4) required credit hours.

Experienced governing body members shall complete a minimum of four (4) credit hours of training courses from Table 2.

Expired training courses that are no longer approved for credit are included in Table 3.
