FINDINGS AND RECOMMENDATION

Pursuant to Tenn. Code Ann. § 49-13-108, sponsors proposing to open new charter schools may appeal the denial of their amended applications by a local board of education to the State Board of Education (State Board).

On May 3, 2012, a hearing was held at the Shelby County Board of Education in Memphis, Tennessee, to consider Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium's appeal of the denial of their applications by the Memphis/Shelby County Unified Board of Education.

Based on the following procedural history and findings of fact, I believe that the decision to deny Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium's application was "contrary to the best interests of the pupils, the school district, and the community", and therefore recommend that the Board remand the decision back to Memphis/Shelby County Unified Board of Education with instructions to approve these applications. Due to the onerous delay that these applicants have endured, I am also recommending that the Board strongly encourage Memphis/Shelby County Unified Board of Education to approve the applications at their next regularly-scheduled board meeting.

PROCEDURAL HISTORY

- 1. The Memphis City/Shelby County Unified School Board of Education denied the amended applications of Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium on October 25, 2011.
- 2. Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium amended and resubmitted their applications.
- 3. The Memphis City/Shelby County Unified School Board of Education denied the amended applications of Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium on November 22, 2011.
- 4. Because the denial was based solely on substantial negative fiscal impact, Memphis/Shelby County Unified Board of Education submitted documentation to the State Treasurer, David Lillard, on November 28, 2011. ¹
- 5. On April 4, 2012, the State Treasurer determined that Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium's chartering would not have a substantial negative fiscal impact.
- 6. The applicants then appealed the denial by email to the State Board in the following order: Memphis Grizzlies Preparatory- received April 4, 2012; Arrow Academy of Excellence, Aurora Collegiate Academy, and City University Schools- received April 5, 2012; and W.E.B. DuBois Consortium- received April 9, 2012.

The Memphis City Charter School Review Committee reviewed the following individual school applications: Arrow Academy of Excellence, Aurora Collegiate Academy, City University School of Independence, City University Girls Preparatory, DuBois Elementary School of Arts and Technology, DuBois Middle School of Arts and Technology, DuBois High School of Arts and Technology, DuBois Elementary School of Entrepreneurship, DuBois Middle School of Entrepreneurship, DuBois High School of Entrepreneurship, DuBois High School of Teacher Education, DuBois Middle School of Leadership and Public Policy, and DuBois High School of Leadership and Public Policy.
- 5. Using the Tennessee Department of Education's (TDOE) scoring criteria for the application, the review committee scored the application in each of the four domains outlined on the TDOE scoring sheet: Mission, Education Plan, Founding Group, Business/Operations Plan.
- 6. To be recommended for approval to the Memphis/Shelby County Unified Board of Education, applicants must score at least 86% in each of the four domains.
- 7. On the initial application, scores were labeled according to the scoring criteria developed and promulgated by the Tennessee Department of Education. The score distribution was as follows:

- 8. After the Memphis/Shelby County Unified School Board voted to deny Arrow Academy of Excellence, Aurora Collegiate Academy, City University Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium's initial applications, Memphis City and Shelby County Schools sent the applicants the complete recommendation report of the committees, the average scores from the committees, and overall reasons for denying the applications.
 - 9. On the amended applications, the score distribution was as follows:

- 10. After review of the applications submitted to Memphis City Schools, though each application met the benchmarks established by the District, Memphis City Director of Schools recommended denial of the charter applications due to substantial negative fiscal impact.
- 11. After review of the applications submitted to Shelby County Schools, namely DuBois Middle School of Leadership and Public Policy and DuBois High School of Leadership and Public Policy, the committee unanimously recommended approving the amended applications.
- 12. Ultimately, the Unified Board denied all the charter applicants, determining that the authorization of the charters would have a substantial negative fiscal impact to the overall school district budget. Beyond fiscal impact, no other concerns were cited.

CONCLUSION

Pursuant to T.C.A. 49-13-108(b)(2), the State Treasurer, David Lillard, determined that

the approval of Arrow Academy of Excellence, Aurora Collegiate Academy, City University

Schools, Memphis Grizzlies Preparatory, and W.E.B. DuBois Consortium schools would not

have a substantial negative fiscal impact on Memphis City and Shelby County Schools. His

determination is final, thus that issue will not be considered in my recommendation.

State law requires the State Board of Education to review the decision of the local board

of education and determine whether the denial of the charter school was in the "best interest of

the students, school district, and the community." ² At the May 3 hearing, neither Memphis City

nor Shelby County Schools raised concerns about the merits of the applications. Because of this,

I believe that the decision to deny these applications was contrary to the best interests of the

"students, school district, and the community."

Therefore, based on the above findings, I recommend that the State Board of Education

remand the decision back to Memphis/Shelby County Unified Board of Education with

instructions to approve these applications. Due to the onerous delay that these applicants have

endured, I am also recommending that the Board strongly encourage Memphis/Shelby County

Unified Board of Education to approve the applications at their next regularly-scheduled board

meeting.
