

# Get to Know the Educator License Discipline Team



# **Overview**

The State Board of Education has authority over the issuance, denial, reprimand, suspension, and revocation of preK-12 teacher and administrator licenses and permits as governed by state law and State Board of Education Rule 0520-02-03-.09. The SBE Educator License Discipline (ELD) Team supports the work of the Board as it relates to Educator License Discipline. Three (3) attorneys and two (2) paralegals directly handle every case reported to the Board via TN Compass. The work of the ELD team is collaboratively managed by the Deputy General Counsel. There were 911 disciplinary reports made in 2023, which led to 453 open cases.

The ELD team hails from diverse backgrounds, bringing a wealth of experience and passion for the work.
