### **Commission Update**

As a result of the increasing number of Commission studies requested by the Tennessee General Assembly over the last few years, and concern that the volume of those studies might lesson the quality of Commission research, House Speaker Cameron Sexton, in consultation with TACIR Chairman Mike Carter, developed a new study referral process during this past session. Rather than referring studies by public chapter or by individual committee vote, Speaker Sexton directed the House committees to refer all proposed TACIR studies to the House Calendar and Rules Committee, which will establish a special calendar to hear and decide on each of the proposals.

Of course, because of the COVID-19 pandemic's disruption of the session, the new referral process was not used this session. We anticipate it will go into effect next session. As of the end of the session, the Senate had not established a comparable process to date, but Lieutenant Governor McNally's office said they will work with the House on referrals.

Next, staff has developed a proposed addition to the commission's bylaws to recognize the existence of the new legislative process and to formalize the process for approving requests by Commission members. Staff suggests voting on the proposed new article, which requires approval by the Commission members, at our next meeting. The proposed article follows.

## **Article VIII**

### **Process for Adoption of Studies into the TACIR Work Program**

Studies may be requested of the Commission by the legislative referral process developed in consultation with the leadership of the Tennessee General Assembly or at the request of a Commission member. Requests made through the legislative referral process require a majority vote of the Commission members present and voting, provided there is a quorum. Study requests by Commission members require an affirmative vote of seventeen (17) Commission members who are present and voting.

#### **Staff Update**

Finally, we were fortunate to have had Duke Gear, a student in the Master of Public Policy and Administration program at the University of Tennessee at Knoxville, serving with us as an intern this summer. Duke also holds a Bachelor degree from UTK, graduating Magna Cum Laude in 2019 with a major in political science and a minor in economics. Previously, Duke served as an intern with the Office of the Chief Clerk of the House of Representatives in the Tennessee General Assembly from January to May of 2019.
