SUBJECT: Fiscal Federalism Website—Update

In 2017, Commission staff added Fiscal Federalism information to the Commission's website—presenting information on how funding flows throughout the intergovernmental system. Staff are working to revise these web pages with updated data organized in a new format with more detailed information.

In revising the Fiscal Federalism web pages, Commission staff have several goals, including:

- updating data to include the most recent federal fiscal years;
- organizing data into a new format with more categories and subcategories, to allow for
 - o easier cross-county comparisons,
 - o easier-to-understand information for individual counties, and
 - o easier updating of the web pages in the future.

Revenue by source data is taken from the Tennessee Office of the Comptroller's county audit database, which includes 91 of the 95 counties in Tennessee. While individual county audits are available to the public, this database the Comptroller's Office has built compiling audit data is not. Commission staff has worked to make this information accessible and understandable for the average citizen.

The other type of information presented on the TACIR Fiscal Federalism website is funding obligated by the federal government more generally benefiting each county and not just county government—for example agricultural subsidies and direct Social Security and veterans' benefits payments. Obligations include amounts that can cross multiple federal fiscal years, such as for multi-year grants and contracts and do not necessarily reflect the amount of money spent in that federal fiscal year. This information is publicly available from the federal USASpending.gov website but is somewhat complicated to access and understand. TACIR staff are working on organizing and presenting information from these two valuable sources in a format easier for the average citizen to utilize. This would provide a robust picture of the funding to counties in Tennessee.

Behind tab A are examples of local tax revenue from the county audit database for state fiscal year 2021-22 for two counties—Bradley and Roane compared to the current format. Behind Tab B are sample summaries of federal obligations for federal fiscal year 2021-22 in the new format for those same two counties compared to the current format. The updated web pages will show much greater federal detail for each county—amounts for all federal obligations performed in each county by department and categories of spending.

Commission staff welcome any feedback regarding the revision of the Fiscal Federalism web pages.
