Six Month TIBRS Data Review

It is time for the six month data review. Every six months, the Crime Statistics Unit reviews each agency's Crime in Tennessee page. This page is a summary of the year's TIBRS data and will include submissions from January 1, 2012 through June 30, 2012. Along with your Crime in Tennessee page, the CSU will include a Hate Crime & LEOKA six month data page and a review sheet identifying any datarelated issues.

Agencies may run their own Crime in Tennessee pages at any time using the <u>www.tncrimeonline.com</u> website. The reports used for the data review are also available on the website so that agencies can periodically review their own data for quality control issues and/or data errors.



Changes to Agency Contact Information



Please notify CSU of any changes in contact information as soon as possible—particularly e-mail addresses. In the coming months, the CSU will be increasing the amount of communications sent via e-mail and decreasing mailed correspondence. As such it is critical that we have accurate e-mail addresses to ensure timely receipt of important memos, updates, etc. Please contact Steven Jancarek or Jackie Vandercook with updated e-mail addresses.

Testing New Repository

Testing of the new repository has begun! The CSU is currently testing all agencies' data. Those agencies utilizing vendor software may receive "test" error reports beginning in mid-July. These reports will show errors identified with the new repository that were not flagged by the system used in the production environment currently.

Please provide these error reports to your vendor for system correction. Please notify your vendor to send us



test files with the Cargo Theft field and the property/location codes. Test files should be e-mailed directly to Jackie.Vandercook@tn.gov and indicate New System Test File in the subject line.

Also on schedule to begin in mid-July is the testing of the new additions such

as Cargo Theft as well as the new property and location codes.

We are on target to deploy the new repository in production on September 1st to accept August data with the changes.

More changes to the repository are expected in early 2013. These will be discussed in detail at the upcoming annual TIBRS conference, and letters will be sent to all vendors and agencies using vendors around the first of September.

Register Now for 2012 TIBRS Conference

Online registration for the TIBRS 2012 Conference is now open! Early Registration ends August 27, 2012; registration and/or payment must be postmarked by this date in order to qualify for the early conference fee amount of \$90 per person. Any registration submitted after the given deadline will be subject to the late registration fee amount of \$120 per person. The very last day to cancel registration and receive a full refund is September 4, 2012.

The CSU strongly encourages agencies to register online at <u>www.tbi.tn.gov</u>. The link for registration along with the pdf version of the conference registration packet is posted on the TIBRS homepage. Click on the Law Enforcement Only link (username— lawenforcement; password—Tennessee1) and then click on the Tennessee Incident Based Reporting System link on



the right. The conference registration link will be on that page.

In order to receive the conference rate on hotel rooms at the Music Road Inn and Conference Center, reservations must be made by August 16, 2012. The conference will be held Monday September 17th through Wednesday September 19th . 9/17/2012—Registration

When Is Monthly TIBRS Data Due?

TnCOP Agencies

For agencies utilizing TnCOP software, the CSU staff begins extracting monthly data submissions on the 1st working day of the month. The date range used for data extraction is always the entire <u>previous</u> month. As such, any data entry completed from the first through the last day of the month will be included in the extraction file. Any data entered after the month has ended will be included in the next month's file.

Example: It is July 6th and you are frantically trying to enter June incidents so the TBI will get them by July 10th. STOP! We will not get any data

entered from July 1st forward until we extract the July data file beginning on August 1st.

Vendor Agencies

Agencies utilizing vendor software are required to submit monthly data files by the 10th of each month; however it would be a tremendous help to the CSU staff if data files are received by the 5th of the month if at all possible. This allows us sufficient time to ensure the data is processed and made available at the <u>www.tncrimeonline.com</u> website as quickly as possible.

The TIBRS data has become an invaluable resource for crime statistics information used by a wide range of policy makers. The CSU provides data on a monthly basis to a state subcommittee on crime. We want to provide as complete a monthly crime picture as possible and data submissions by the 5th allows us to meet that goal.
