



More than one in five high school students reported they had seriously considered attempting to take their life within the last 12 months.



HIGH SCHOOL GIRLS MENTAL HEALTH

Restrictive Eating

More than half of girls reported they had eaten less food or foods low in fat to keep from gaining weight.

More than one in three girls had taken one of the following actions within the last 30 days to try to lose weight or keep from gaining weight:

- Gone without eating for 24 hours or more
- Taken diet pills, powders or liquids
- Vomited or taken laxatives
- Smoked cigarettes
- Skipped meals.

Non-Suicidal Self-Harm

Compared to boys, girls were twice as likely to report non-suicidal self-harm within the last 12 months at 34.5 percent.

Abuse & Trauma

Among those who dated someone in the last year, one in eight Tennessee high school girls were in a physically violent relationship within the last year.

Among MNPS students, nearly 1 in 4 12thgrade girls reported an adult or someone at least 5 years older than them had made them do sexual things they did not want to do.

One in eight Shelby County students and one in nine Metro Nashville students reported they had been physically forced to have sexual intercourse.





OF TENNESSEE CHILDREN ARE COVERED BY TENNCARE. THE PERCENT OF CHILDREN COVERED BY TENNCARE HAS INCREASED 31 PERCENT OVER THE LAST DECADE, GOING FROM 42 PERCENT IN 2012 TO 55 PERCENT IN 2022.

INFANT MORTALITY

Of the 38 Organisation for Economic Co-operation and Development (OECD) countries, the United States has the 6th highest infant mortality rate.


After a slight decline between 2019-2021, the infant mortality rate in Nationally and in Tennessee increased in 2022.^{44,45}

In 2021, Tennessee saw the highest number and rate of unintentional infant deaths due to suffocation since before 1999.




INFANT SUFFOCATION DEATHS

Tennessee has consistently had a higher rate of unintentional infant deaths due to suffocation. In 2021, the Tennessee rate was 2.75 times higher than the United States rate, ranking 2nd highest.^{47, 48}


TIME TO INVESTIGATION

In 2021, the average time between the report of suspected maltreatment and the first face-to-face contact with the alleged victim or with another person who can provide information on the allegation was 4.5 days.



PLACEMENT STABILITY




Of first-time foster children entering the system in 2022, more than one in three had been in three or more placements by June 30, 2023.

Among children entering in 2023, more than one in four had been in three placements by June 30th.

OVERALL CRIME RATE (PER 1,000)




Between 2012-2022, Shelby, Davidson and Hamilton Counties all experienced a decline in the under-18 crime rate.





CRIMES AGAINST SOCIETY RATE (PER 1,000)




Youth are much more likely to be the victim of a firearm crime than to perpetrate one.

In 2022, there were 1,561 crimes involving a firearm where the offender was under 18. During that same time period, there were 4,490 under-age -18 victims of crimes involving a firearm

Victims of crimes involving a firearm have increased by 56 percent between 2012-2022 and victims of firearm crimes with a youth offender have increased 27 percent.

Crimes involving a firearm against a youth victim have increased by 133 percent.

YOUTH IN DETENTION SURVEY



Of youth indicated that someone who lived with them had (or maybe had) been arrested, in jail or detention.

43 percent of youth stated that they or someone they have lived with needed or maybe needed help with mental health or drugs/alcohol.



What would you change about school, court, detention, or probation to make it better or more helpful?

"Let them understand that detention doesnt help troubled kids, it makes them worse. Courts need better programs for serious trouble kids like me. We need more help than just being thrown in a cell."
