



**NOTICE TO CONTRACTORS
REGARDING A REQUEST FOR PROPOSALS
May 6, 2022
(Construction Division)**

The Construction Division of the Tennessee Department of Transportation (TDOT), an Equal Opportunity Affirmative Action Employer, is seeking to retain a Construction Manager/ General Contractor (CM/GC) to provide preconstruction services, and potentially construction services, for the proposed State Route 194 extension from and including the proposed Exit 39 interchange at I-40 to Connector Road and Connector Road to State Route 222 in Fayette and Haywood Counties, Tennessee (Contract **CMGC05**). At TDOT's discretion, the CM/GC services may also include the State Route 194 extension from Connector Road to State Route 1 in Haywood and Tipton Counties, Tennessee, and the State Route 194 extension from I-40 at the proposed Exit 39 interchange to State Route 59 in Fayette and Haywood Counties, Tennessee. TDOT is seeking a contractor with experience, at a minimum, in the following:

1. Bridge design and construction with Accelerated Bridge Construction (ABC) Experience.
2. Freeway design and construction.
3. Hydraulic design and construction; and
4. Environmental regulatory and compliance.

The mandatory Pre-Proposal meeting will be held on May 20, 2022, at TDOT Region 4 Auditorium, 300 Benchmark Place Jackson, TN 38301, at 10:00 am (C.T.). Failure of a contractor to attend any such meetings will result in elimination of that contractor, and any proposal submitted by that contractor will be rejected.

Certified Disadvantaged Business Enterprises (DBEs), including Woman-Owned and Minority-Owned Businesses, are encouraged to respond to all advertisements by the Department of Transportation.
