DESIGN BUILD PROJECT**

The Construction Division of the Tennessee Department of Transportation (TDOT), an Equal Opportunity Affirmative Action Employer, is seeking to retain the services of Design-Builders for **I-75 Interchange @ I-24 Phase 2, Hamilton County, Tennessee**, with experience in the following, but is not limited to:

1. Bridge Design and Construction.
