Book 1 Section 1.3	RFP Book 1, Section 1.3 indicates that questions are due 11/15/2024. May the due date for questions be extended to 11/22/24 providing more time for Proposers to review the RFP and Reference Material?	See revisions to Section 1.3 (Procurement Schedule) in Addendum #1.  TDOT has extended the deadline to submit ATCs, but is holding the date for Proposers to submit questions and request for changes to the QPL.
Book 1 Form B	RFP Book 1, Section 3.2.2.2 states that the Proposer is to provide projects "that have been completed in the last 15 years". The header on Form B states "Summary of Comparable Contracts in Past Ten (10) Years".  Please confirm with projects need to be complete within the past 10 or 15 years.	See revisions to Form B in the Book 1 Forms posted on the Project website.  The RFP requirement to include projects within the last 15 years is correct. Form B has been updated to delete the inconsistency.
Book 1 Section 3.3 and Forms	RFP Book 1, Section 3.3 indicates that Volume II of the Technical Proposal is to consist of three sections: 1) Project Management Approach, 2) Design Approach, 3) Construction Approach. These sections are further detailed in sections 3.3.1 through 3.3.3.  RFP Book 1 also includes Response Category II-IV Forms that do not align with the three sections listed in Section 3.3 or their subsections. The forms include the following sections.  Response Category II: Organization and Project Expertise.  Response Category III: Project Understanding, Schedule Management, Project Management, Environmental Compliance, and Innovation.  Response Category IV: Technical Solution.  Please confirm if Proposers should respond to Volume II of the Technical Proposal per Sections 3.3.1 through 3.3.3 of Book 1 or if the Response Category Forms should be used.	See revisions to Section 3.2.2 and Section 3.3 in Addendum #1.  The forms for "Response Categories II-IV" were inadvertently added to the Book 1 Forms. These forms have now been deleted from the revised Book 1 Forms posted on the Project website. The Proposer may respond in free form following the order of the sections listed in Section 3.2.2 and 3.3.

Book 1 Form ATC	RFP Book 1, Section 2.2 details 12 items that each ATC shall include. There is also an ATC Submittal Form at the end of Book 1 which includes only 9 items, some with varying language from that of Section 2.2. Please confirm if the ATC Submittal Form is to be used and confirm the correct criteria to be submitted with each ATC.	See revisions to Form ATC in the Book 1 Forms posted on the Project website.  The form now matches the list of ATC submittal requirements in Section 2.2.
Book 1 Section 3.2.2	RFP Book 1, Section 3.2.2.2 states that the Proposer is to provide projects “that have been completed in the last 15 years”. May the Proposer submit Form B descriptions on projects that are currently in progress and not yet complete?	See revisions to Section 3.2.2.4 in Addendum #1.  The Proposer <b>must</b> provide a minimum of four project descriptions for completed work over the last 15 years per the requirements of Section 3.2.2.4. However, the Proposer may also submit up to four additional Form B project descriptions to highlight on-going/current work.
