## NOTICE TO DESIGN-BUILDERS REGARDING REQUEST FOR QUALIFICATIONS (RFQ) MANADATORY MEETING

The Alternative Delivery Division of the Tennessee Department of Transportation (TDOT), an Equal Opportunity Affirmative Action Employer, is seeking to retain the services of a Design-Builder for **DB2506**, **Timber Bridge Bundle** (Project), located in **Lauderdale and Haywood Counties**, **Tennessee**, with experience in disciplines including:
