

**NOTICE TO ENVIRONMENTAL SERVICES FIRMS  
REGARDING A REQUEST FOR LETTERS OF INTEREST**

**October 6, 2017**

**Environmental Division – Construction Quality Assurance & Corrective Action Section**

The Tennessee Department of Transportation (TDOT), an Equal Opportunity, Affirmative Action Employer, seeks to retain the services of professional environmental services firms for on-call Construction Quality Assurance and Corrective Action services described below. A total of eight (8) contracts may be awarded, as follows:

**Item No. 1:** Construction Quality Assurance and Corrective Action services for Region 1 (2 contracts);

**Item No. 2:** Construction Quality Assurance and Corrective Action services for Region 2 (2 contracts);

**Item No. 3:** Construction Quality Assurance and Corrective Action services for Region 3 (2 contracts); and

**Item No. 4:** Construction Quality Assurance and Corrective Action services for Region 4 (2 contracts).

**Contract Term, Maximum Contract Amount, and Method of Payment:**

The contract term shall be five (5) years. Each agreement shall be effective as of April 1, 2018, and shall terminate March 31, 2023, except to the extent necessary to allow completion of previously issued work orders. New work orders will be issued only within the first three (3) years.

The initial contracts shall be \$1,000,000 each. The contract ceiling may be increased, as needed, but in no event shall the contract exceed \$1,500,000.

The method of payment for each contract will be cost plus fixed fee.

**Required Scope of Services:**

1. Quality assurance site inspections and assessments for TDOT construction projects related to issued environmental permitting; and
2. Response to environmental issues, including sediment releases, associated with active TDOT construction projects. This work may include, but not limited to, site response, development of a corrective action plan, oversight/implementation of corrective action plan, and development of a final report.

**Letter of Interest Requirements; Contact information:**

Firms may request consideration by submitting a letter of interest addressed to **Ms. Susannah Kniazewycz, Director, TDOT Environmental Division, Suite 900, James K. Letters must include a one to three page attachment that (1) briefly addresses how the firm meets the minimum criteria of the Phase I Evaluation; and (2) indicates if any sub-consultants are anticipated to perform a portion of the work. The letter of interest shall specifically identify sub-consultant(s), and indicate the scope of services anticipated to be completed by sub-consultant(s). All firms must be pre-qualified or have a completed prequalification form filed with the Department prior to the deadline for the letters of interest.

Letters of interest must also include the following information: **point of contact, telephone number and a valid email address.** Submittals must be provided in .pdf format and submitted in person on CD or by email to [TDOT.Env.BusinessServices@tn.gov](mailto:TDOT.Env.BusinessServices@tn.gov). All letters of interest must be received by the Environmental Division on or before **4:00 p.m. (Central Time), October 20, 2017.**

### **Phase I Evaluation:**

The Department will evaluate the current DT-330 Part I Prequalification Statements on file for those firms submitting letters of interest and choose several firms who would make viable candidates from which to invite proposals and/or presentations. **To be considered, a prospective firm must provide documentation demonstrating that it meets all of the following minimum criteria:**

- a. Maintain at least 2 staff that have TDEC Level 2 Certification (Design Principals for Erosion Prevention and Sediment Control for Construction Sites) or CPESC (Certified Professional in Erosion and Sediment Control) Certification;
- b. Demonstrated ability to conduct QA inspections on active construction projects evaluating compliance with issued state and federal environmental permitting; and
- c. Demonstrated ability to conduct environmental assessments (including sediment assessments), provide oversight and development of documentation related to required site restoration or remediation.

### **Phase II Evaluation:**

The Department will evaluate the submitted DT-330 Part II Contract Specific Questionnaire on the following criteria (relative weight):

- a. Past experience in conducting Quality Assurance (QA) Inspections on construction projects evaluating compliance with issued environmental permitting for TDOT and / or other clients (40%);
- b. Past experience conducting environmental assessments (including sediment assessments), providing oversight for needed clean-up or restoration work, and preparation and submittal of required documentation (10%);
- c. Staff's relative qualifications, education, credentials /licenses within Tennessee (25%);
- d. Evaluations of work performed on prior TDOT QA inspection projects (if available) (15%);
- e. Staff's specific office location relative to the TDOT Regional Administration Facility for the contract item number (5%); and
- f. Participation of qualified and certified Disadvantaged Business Enterprise sub-consultants (5%).

### **Phase III Evaluation**

From the list of firms determined by the Consultant Evaluation Committee to be the most highly qualified firms to perform the solicited services, the Commissioner will rank the firms in order of preference. Contracts will be awarded to the two (2) top-ranked firms for Items 1-4 for a total of 8 contracts.

**Work Orders:**

Individual work order assignments will be made based on the Region to which the contract is assigned, and within each Region work order assignments will be made on qualifications based criteria that may include, but are not limited to:

- a. Consultant availability to perform the work;
- b. Qualifications of the consultant to perform the work specific to the work order; and
- c. Specialized expertise specific to the work order.

**Equal Opportunity Commitment:**

Evaluation proceedings will be conducted within the established guidelines regarding equal employment opportunity and nondiscriminatory action based upon the grounds of race, color, religion, national origin, sex, creed, age, and disability. Interested certified Disadvantaged Business Enterprise (DBE) firms as well as other minority- and/or women-owned firms are encouraged to respond to all advertisements by TDOT.
