2019 TDOT OS/OW Holiday Travel Restrictions 2019	
JANUARY 21	Our office will be closed Monday, January 21 for Martin Luther King Day. Normal travel allowed with permit except; Mobile Homes, Site-built houses and House boats.
FEBRUARY 18	Our office will be closed Monday, February 18 for President's day. <ul style="list-style-type: none">• Normal travel allowed with permit except; Mobile Homes, Site-built houses and House boats.
APRIL 19	Our office will be closed Friday, April 19th for Good Friday. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after Six o'clock PM (6:00 PM) on April 18th through April 21st.• Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized.• No Travel on April 21st for Mobile Homes, Site-built houses and House boats.
MAY 27	Our office will be closed Monday, May 27 th for Memorial day. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on May 24th through May 27th.• Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized.• No travel on May 27th for Mobile Homes, Site-built houses and House boats
JULY 4	Our office will be closed Thursday, July 4 th for Independence day. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on July 3rd through July 4th.• Oversized/Overweight loads NOT requiring escorts for movement are allowed Continuous travel with normal travel conditions as authorized.• No travel on July 4th for Mobile Homes, Site-built houses and House boats.
SEPT 2	Our office will be closed Monday, September 2 nd for Labor Day. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on August 30st through September 2nd.• Oversized/Overweight loads NOT requiring escorts for movement are allowed Continuous travel with normal travel conditions as authorized.• No travel on September 2nd for Mobile Homes, Site-built houses and House boats.

<p>NOV 27- DEC 1st</p>	<p>Our office will be closed Thursday, November 28th and Friday, November 29th.</p> <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon November 27th through December 1st.

<p>DEC 24-25</p>	<p>Our office will be closed Tuesday, December 24th and Wednesday, December 25th.</p> <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on December 24th through December 26th • Oversized/Overweight loads NOT requiring escorts for movement are allowed Continuous travel with normal travel conditions as authorized. • No travel on <u>December 25th</u> for Mobile Homes, Site-built houses and House boats.
<p>DECEMBER 31, 2019 JANUARY 1, 2020</p>	<p>Our office will be closed Tuesday, December 31st, and Wednesday, January 1st.</p> <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on December 31st through January 1st . • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on <u>January 1st</u> for Mobile Homes, Site-built houses and House boats
	<p>The movement of mobile homes subject to this rule shall be permitted only from sunrise to sunset, Monday through Saturday; provided, however, that movements of mobile homes shall not be permitted on legal holidays as enumerated in T.C.A. § 15-1-101, including New Year's Day, Martin Luther King, Jr. Day, Washington Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day and Christmas Day.</p>
