JANUARY 15	Our office will be closed Monday, January 15 for Martin Luther King Day. Normal travel allowed with permit except; Mobile Homes, Site-built houses and House boats.	
FEBRUARY 19	Our office will be closed Monday, February 19 for President's day. <ul style="list-style-type: none"> • Normal travel allowed with permit except; Mobile Homes, Site-built houses and House boats. 	
MARCH 30	Our office will be closed Friday, MARCH 30th for Good Friday. <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after Six o'clock PM (6:00 PM) on March 29th through April 1st. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No Travel on March 30th for Mobile Homes, Site-built houses and House boats. 	
MAY 28	Our office will be closed Monday, May 28 th for Memorial day. <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on May 25th through May 28th. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on May 28th for Mobile Homes, Site-built houses and House boats 	
JULY 4	Our office will be closed Wednesday, July 4 th for Independence day. <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on July 3rd through July 5th. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on July 4th for Mobile Homes, Site-built houses and House boats. 	
SEPT 3	Our office will be closed Monday, September 3 rd for Labor Day. <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on August 31st through September 3rd. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on September 3rd for Mobile Homes, Site-built houses and House boats.

DECEMBER 31, 2018 JANUARY 1, 2019	<p>Our office will be closed Monday, December 31st Tuesday, January 1st and Wednesday, January 2nd.</p> <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on December 28th through January 2nd. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on <u>January 1st</u> for Mobile Homes, Site-built houses and House boats
	<p>The movement of mobile homes subject to this rule shall be permitted only from sunrise to sunset, Monday through Saturday; provided, however, that movements of mobile homes shall not be permitted on legal holidays as enumerated in T.C.A. § 15-1-101, including New Year's Day, Martin Luther King, Jr. Day, Washington Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day and Christmas Day.</p>
