JANUARY 20	Our office will be closed Monday, January 20 for Martin Luther King Day. Normal travel allowed with permit except; Mobile Homes, Site-built houses and House boats.

APRIL 10	Our office will be closed Friday, April 10th for Good Friday. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after Six o'clock PM (6:00 PM) on April 9th through April 12th• Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized.• No Travel on April 12th for Mobile Homes, Site-built houses and House boats.	
MAY 25	Our office will be closed Monday, May 25 th for Memorial Day. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed after twelve o'clock (12:00) noon on May 22nd through May 25th• Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized.• No travel on May 25th for Mobile Homes, Site-built houses and House boats	
JULY 4	Our office will be closed Friday, July 3 rd for Independence Day. <ul style="list-style-type: none">• NO ESCORTED TRAVEL allowed on July 3rd through July 5th.• Oversized/Overweight loads NOT requiring escorts for movement are allowed Continuous travel with normal travel conditions as authorized.• No travel on July 4th for Mobile Homes, Site-built houses and House boats.

<p>DECEMBER 31, 2019 JANUARY 1, 2021</p>	<p>Our office will be closed Thursday, December 31st , & Friday, January 1st.</p> <ul style="list-style-type: none"> • NO ESCORTED TRAVEL allowed on December 31st through January 3rd. • Oversized/Overweight loads NOT requiring escorts for movement are allowed continuous travel with normal travel conditions as authorized. • No travel on <u>January 1st</u> for Mobile Homes, Site-built houses and House boats
	<p>The movement of mobile homes subject to this rule shall be permitted only from sunrise to sunset, Monday through Saturday; provided, however, that movements of mobile homes shall not be permitted on legal holidays as enumerated in T.C.A. § 15-1-101, including New Year’s Day, Martin Luther King, Jr. Day, Washington Day, Good Friday, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans’ Day, Thanksgiving Day and Christmas Day.</p>
