- Intended for the movement of house trailers, portable modular units, each by separate movement, by towing.
- 24 hours, 7 days per week continuous non-escorted movement with normal travel conditions authorized; with exception to county curfew.
- No escorted OS/OW movement of any kind on interstate systems or highways, Monday-Friday 7:00am-9:00am and 4:00pm-6:00pm in Davidson county, Rutherford county, Hamilton county, Knox county, and Shelby county; regardless if carrier is operating on a single trip or annual permit.
- 14ft Mobile Home Annual requires both front and rear escorts on all two lane highways, and only a rear escort required on interstate highway system or four lane highways.
- 16ft Mobile Home Annual requires both front and rear escorts.
- Must have proper OS/OW signage, markings, and lighting.
- **All permit fees are non-refundable.**
- *Applications by Email are accepted with Credit Card Payments Only.*
- *All applications must be submitted with a valid **Certificate of Liability Insurance** that names TDOT 505 Deaderick St Suite 800 Nashville, TN 37243 as a Certificate Holder.*
