

The CRD Title VI Program held the last of its biannual and Title VI Liaison and Title VI Advisory Committee meetings on September 5 and September 7, respectively. During these meetings, Title VI staff shared results of the Annual Employee Title VI training, that TDOT had reached the goal of training 100% of the workforce. Pamela Sharp thanked all of the committee members, acknowledging their significant role in TDOT's success.

Cynthia Howard discussed the internal Title VI assessments, a survey was distributed to each division reporting on its Title VI programs and efforts. Howard explained the importance of completing and returning the assessments as the information provided will be included in TDOT's Title VI Implementation Plans. The CRD Title VI Implementation Plans are due October 1. A state plan is provided to the Tennessee Human Rights Commission and a Federal plan is due to FHWA. In closing, Howard thanked everyone for their assistance in coordinating the Annual Title VI Training.

### 2017 FHWA and THRC Implementation Plans to be Submitted

The Civil Rights Division (CRD) Title VI Program Staff is required to report annually on its Title VI activities to the Federal Highway Administration (FHWA) and the Tennessee Human Rights Commission (THRC). The CRD is only required to submit annual updates (which delineate program changes and highlights compliance reviews, accomplishments, outreach efforts, and Title VI complaints and resolutions). These reports, federal and state plans, provide the CRD an opportunity to highlight its interdisciplinary approach to accomplishing Title VI compliance within TDOT. Furthermore, it provides a platform for demonstrating how the CRD endeavors to ensure TDOT's subrecipients are in compliance with Title VI of the Civil Rights Act of 1964. More importantly, it provides FHWA and THRC an opportunity to distinguish the "what, when, why and how" behind TDOT Title VI Program's implementation and execution of the Federal and State mandates.

The CRD's Title VI Implementation Plans are due for submission on or before October 1, 2017.





# Title VI Regional Subrecipient Training



Training on Title VI and the nondiscrimination mandates plays an intrical role in combating discrimination in federally funded projects and activities. That is why training is a huge component of TDOT's Title VI Program. Annually, the Civil Rights Division (CRD) Title VI staff conducts Regional Title VI trainings, one per region. From May through September, staff transverse the state, ensuring that TDOT's Subrecipients are provided an opportunity to participate in onsite training. The trainings enable newcomers and those wanting a refresher to interact with staff, providing answers to questions and facilitating discussions. The regional trainings provide an overview on the historical origin of Title VI of the 1964 Civil Rights Act and supporting nondiscrimination legislation.

TDOT Subrecipients can, and do, utilize the automated online Title VI Subrecipient training. This fiscal year, nearly 600 people participated in the online training. The dates of the Regional Title VI training are forecast at https://www.tn.gov/tdot/article/title6-training where Subrecipients can also register.



The City IDB is a public, nonprofit organization that promotes industrial development and provides job opportunities in the City of Knoxville. The board's authorities include, 1) accepting land grants from local government; 2) economic development incentives, including acquisition and development of land for project sites, construction or renovations of buildings and acquisition of equipment and other personal property; 3) construction of onsite and offsite infrastructures, i.e., utilities, sidewalks, public parking, and other improvements; and, 4) tax abatements or PILOTS programs and tax increment financing (TIF).

The IDB Downtown Cinema performs public functions on behalf of the City of Knoxville. Authorized under State law, the Cinema IDB was formed for the purpose of financing, developing and administering the Downtown Regal Riviera Stadium 8.

Both boards, City IDB and IDB Downtown Cinema, consist of a nine-member Board of Directors who are nominated by the Mayor and confirmed by City Council. Finch's term of service is January 1, 2017 to December 31, 2022. Please join us in congratulating Mr. Finch.





## 2017 TSU NSTI Program

Annually, the CRD administers the National Summer Transportation Institute Program (NSTI), which gives the Title VI staff an opportunity to focus on inspiring and shaping tomorrow's leaders. The NSTI is a four-week, federally funded summer program developed to increase the awareness of middle and high school students to the engineering field and other transportation related careers.

The College of Engineering, Technology and Computer Science at Tennessee State University (TSU) in cooperation with FHWA, TDOT, United States Army Corps of Engineers, and the Metropolitan Nashville Airport Authority sponsored this year's program. The 2017 NSTI was held on the campus of TSU from June 5 – June 30, 2017. Twenty 10th and 11th grade students from across the United States participated in this year's program. The students' schedule consisted of classroom activities, laboratories, field trips, guest lectures, and the commissioner's luncheon.

TDOT Week, June 5th – 9th, is normally observed the first week of the program. This week was filled with volunteer speakers from TDOT. The speakers delivered engaging presentations, discussing their roles and responsibilities within TDOT and other career opportunities available in the field of transportation.
