The grading, drainage, construction of a concrete box bridge, signals and paving on S.R. 455 (Tennessee Waltz Parkway) from 1,500 feet south of S.R. 49 (L.M. 0.87) to S.R. 49 (L.M. 1.16).

STANDARD PRE-QUALIFICATION REQUIREMENT

Prime contractors must pre-qualify with The Department of Transportation in accordance with Tennessee Code Annotated 54-5-117, before bid authorization for highway contracts will be granted.

PROSPECTIVE BIDDERS MUST HAVE FILED THEIR QUESTIONNAIRES FOR QUALIFICATIONS AT LEAST FOURTEEN (14) DAYS PRECEDING THE DATE OF LETTING.

MANDATORY PRE-BID MEETING

Prime/joint venture contractors must participate in a pre-bid meeting to be held on November 20, 2020 from 10:00 A.M. – 11:00 A.M., CDT via remote conferencing. Participation in the remote conference is mandatory as part of these special pre-qualification requirements for prime contractors. Subcontractors are encouraged to participate but will be permitted as a subcontractor if unable. If you are bidding as a prime/joint venture or are a subcontractor wishing to participate, please send an email to Jamie.Waller@tn.gov. Emails will be received until November 19, 2020, at 4:00 PM, CDT. Emails received after 4:00 PM, CDT, will not be considered, and participants will be ineligible to participate in the meeting.

All prime/joint venture contractors pre-qualified by the Department must obtain authorization to bid through the standard bid authorization procedure. **BID AUTHORIZATION MUST BE OBTAINED PRIOR TO 4:00 P.M. CDT ON THE DAY PRECEDING THE LETTING.**
